Trustees' report for the year ended 5 April 2021

The trustees present their report and accounts for the year ended 5 April 2021.

The accounts have been prepared on a receipts and payments basis and comply with the charity's governing documents and applicable law.

Objects and activities

The charity's objects are to support organisations dedicated to the relief of poverty and its consequences both at home and abroad, with a particular interest in the support of Christian-run charities.

The policies adopted in furtherance of these objects are the making of grants to suitable organisations. There has been no change in these during the year.

Public benefit

The trustees have had due regard to guidance published by the Charity Commissioner on public benefit. The trustees confirm that they have referred to the guidance when reviewing the charity's aims and objectives and consider public benefit to be provided in the form of grant-giving to organisations whose aim is the relief of poverty.

Achievements and performance

A total of £27,546 (2019: £33,949) was paid out during the year to various individuals and institutions in the furtherance of the charitable objects of the trust. The trustees will continue to support the work of charities or voluntary organisations whose aims fall within the objects of the charity.

Financial review

During the year investment income of £3,760 (2020: £4,867), together with donations of £15,000 (2020: £20,000), gift aid of £10,015 (2020: £nil), and rent of £nil (2020: £nil) were received. This equates to total receipts of £28,775 and represents an increase in total receipts of £3,908 compared to 2020 (£24,867). The trust also paid independent examiner's fees of £1,110 (2020: £1,080).

At the year-end the trust had cash reserves of £35,657 and total net reserves of £139,116. The trustees will continue the policy of distributing income by way of grants within the scope of the net resources of the charity, with any surplus being added to reserves.

Structure, governance and management

The charity is an unincorporated trust constituted by a charitable trust deed on 30 July 1990 by Mr Francis Jonathan Pym and is a registered charity, number 1000449.

The power of appointing new trustees is vested in the founder, Mr Francis Jonathan Pym, during his lifetime.

The day to day administration of the charity is carried out by Mr Francis Jonathan Pym.

The trustees have power to invest in any stocks, funds, shares, securities or other investments or property of whatsoever nature.

The trustees have assessed the major risks to which the charity is exposed and are satisfied that systems are in place to mitigate exposure to the major risks.


Trustees' responsibilities


