Elders during the period under review are David Patterson and Paul Codner. Full time Church workers are Mr and Mrs P Warr who reside in the Church house at 78 Bridge Street.

Trustees during the period under review are Mr Paul Codner, Mr Rodger Osborne, Mrs Delyth Williams Mrs Audrey Burnham. All previously named trustees have either passed away or moved out of the area or have resigned. New trustees are appointed by the existing trustees.

Aims and Objectives.

The church exists to promote the Christian Faith and does by means of evangelism and by the teaching of Christian truth in Wales and elsewhere.

The main activities of the Church during this period are as follows:

Regular Sunday morning meetings for worship and Ministry.

Regular Wednesday morning meeting for prayer.

Regular house group meeting in a nearby town

Regular Friday HUB providing a warm space and free lunch for the community.

We have a monthly Senior Citizens meeting for folk in the community.

We have a fortnightly Art group which meets in the shop part of our premises

Our premises are used by the Citizens Advice Bureau each Monday which serves the town and surrounding area.

Building Work.

We have spent substantial amounts of money improving our property. The roof has been replaced and a new ceiling installed. The shop has been redecorated, and new windows have been installed. We are grateful to Ceredigion County Council for a grant toward this work.

Financial

The church banks with HSBC, Harford Square, Lampeter SA48 7DU and has an account with the Cambridge Building Society.

Mr Eryl Jones of 12 Station Terrace is our accountant who has replaced Mr Ian Afflick who served as accountant for many years.
