TRUSTEES' ANNUAL REPORT FOR THE YEAR ENDED 31 DECEMBER 2022

The Bournemouth Gilbert and Sullivan Operatic Society is a registered charity No 1001687 and its current Officers are:

The Officers of the Society are also the Trustees of the Charity and held office during the entirety of the financial year. The Chairman, Secretary and Treasurer are offering themselves for re-election at the Annual General Meeting to be held in April 2023.

Objects:

The objects of the Society are to educate the public in the operatic arts and to promote the production of operatic works and to assist and further such charitable institutions and purposes, as the Committee shall decide.

Activities during the year

Following the easing of social restrictions during the Covid-19 pandemic, the Society was very pleased to be back performing in 2022. Firstly the spring show *For the Love of Music* at 3 local venues. Secondly, we returned to Poole Lighthouse in October with a 'steampunk' version of *The Pirates of Penzance*. Lastly we also performed *A Christmas Cracker* concert at 2 local venues plus a charity event at Beaulieu Palace House. Whilst all 3 shows were well-received by audiences, Pirates in particular, it was regrettable that ticket sales were really difficult to drive, leading all 3 shows to make losses which can be seen in the Productions Account on page 7 of the financial statements. We also continued our traditional carol singing performed at 2 Masonic lodges raising a further £1,115 for Macmillan Caring Locally.

The overall result has been a loss on general funds of £14,324 compared to the 2021 net loss of £2,755. At year end the Society had £19,735 of liquid assets.

Plans for 2023

The impact of losses from 2022 and more especially the depletion of performing members within the society has required us to revise the scope of our plans for 2023 and we are currently looking at an October production which requires only a smaller and female-centred cast. The future outlook for the society is very dependent on being able to recruit new members.

I have completed my examination. I confirm that no material matters have come to my attention in connection with the examination which give me cause to believe that in any material respect:


The accounting records were not kept in accordance with section 130 of the Charities Act: or
