
- (1) The Trust was established by a Charitable Trust Deed dated 10 December 1990. The stated purpose of the trust is the relief of the poor and needy and the support of such other charitable purposes, institutions, societies or objects 'as the Club shall in duly constituted meetings from time to time direct.
- (2) The Trust has received a total of £25,985 in grants, donations and fundraising income during the year. This includes the "Dinner Money" scheme, which has now been closed.
- (3) Distributions paid during the year totalled £20,612.35 and are listed on the Grants and Donations Schedule.
- (4) The Marathon is now operated by a third party commercial business. The Trust Fund receives a fixed fee per starter and donations were made from this amount. As we are no longer financially responsible for the Marathon, the balance of the Marathon Reserve has been transferred to Unrestricted Funds.
- (5) Accounts to 30 June 2025 are attached. These accounts have been approved by the Trustees and members will be asked to vote to adopt the Accounts at the Special General Meeting





- (2) The Trust has received a total of £38,595 in grants, donations and fundraising income during the year. This includes £4,579 to the "Dinner Money" scheme, which comes from Club members and associated Gift Aid
- (3) Distributions paid during the year totalled £23,491 and are listed on the Grants and Donations Schedule. This includes £4,914 under the "Dinner Money" scheme
- (4) The Marathon is now operated by a third party commercial business. The Trust Fund receives a fixed fee per runner and donations were made from this amount and from a surplus from a Tombola stall. As we are no longer financially responsible for the Marathon, the balance of the Marathon Reserve has been transferred to Unrestricted Funds.
- (4) Accounts to 30 June 2024 are attached. These accounts have been approved by the Trustees and members will be asked to vote to adopt the Accounts at the Special General Meeting on 14th April 2025


I report to the charity trustees on my examination of the accounts of the charity for the year ended 30th June 2024 which are set out on pages 2 to 9.
