TRUSTEES' ANNUAL REPORT FOR THE PERIOD JANUARY TO DECEMBER 2020

CHARITY NAME: KNOW YOUR BIBLE UK

OBJECTIVES AND ACTIVITIES

Our objective is: The transformation of women's lives through the power of God's Word.

Our vision is:

- To bring women to a personal knowledge of Jesus Christ as Saviour
- To deepen and enrich the spiritual lives of women
- To equip women for life's challenges so they might be a positive influence in their homes, work and communities
- To enable women to play a more effective role in their own churches and in all their service for the Lord.

These objectives are achieved through the following activities.

- Provision of high quality Bible study materials in the form of books

- Bible study groups meeting across the UK. In this year of the pandemic groups have been unable to meet face to face so many groups have continued to meet on-line. Area leaders and group leaders have maintained contact with members by telephone or video calls.

- Area and residential national conferences. During 2020 due to the restrictions imposed by the pandemic no face to face area conferences or quiet days have been held, nor has the annual residential conference taken place. However, the National Leadership Team have kept in touch via video conferencing with area groups.

- Relaunching of the Know Your Bible website which provides much information about our operation and what is on offer for individuals and groups.

- The launching in September 2020 of the Know Your Bible YouTube channel. Two programmes were produced in 2020 one in September and one in December. A further one has been shown in 2021.

ACHIEVEMENTS AND PERFORMANCE OF THE CHARITY IN 2020

- Making the switch from face to face study groups to on-line meetings has proved to be increasingly popular and effective and has attracted new members. An added benefit has been that this has allowed individuals to join a group which is not geographically close to them. It has also led to the establishing of new groups.

- Launching of a new website has enhanced the profile of the charity and been populated with a lot of useful information for visitors to the site. The information is regularly updated.

-Pastoral care within groups has had to switch on-line and over the telephone. This has had the added benefit of greater accessibility to pastoral care and increased prayer support for those in need.

-Communication between the Trustees and National Leadership Team has been enhanced with moving to on-line meetings with these taking place more regularly. This has greatly reduced the financial burden on the charity. As this approach has been effective and efficient it is likely this will be continued after the restrictions due to the pandemic are lifted.

-Support for area leaders has also been enhanced with the use of on-line meetings giving opportunity for discussion, encouragement and prayer. As well as contributing to planning for the future. Already this is having a positive effect on a more shared identity within the whole work of the charity.

-The Trustees have updated their policy on Data Protection and Safeguarding. They have produced guidelines on operating within a pandemic.

PUBLIC BENEFIT

The Trustees have paid due regard to the Public Benefit guidance by the Charity Commission evidenced in the following ways:

-We recognise that studying God's Word doesn't just have an educational benefit but also will lead to the transformation of peoples' lives equipping them for life's challenges so they might be a positive influence in their homes, work and communities. Thus fulfilling our stated objective and vision.

-Studying God's Word together often leads to the identification of peoples' gifts, skills and attributes equipping them to be a positive influence and, in some cases, take leadership responsibility in their homes, work, churches and in their communities.

-Area and group leaders provide pastoral care to group members giving vital support to those who are struggling with the challenges of life. This has been particularly important during the pandemic. Meeting regularly on-line has given a life line to those who are isolated and alone and made a positive impact on their mental, emotional and spiritual well-being.

FINANCIAL REVIEW

In previous years, no account had been taken of the income and expenditure of the area groups, which hold bank accounts under the charity's registration. As a result, the 2019 accounts have been restated. The total held in the areas' bank accounts at 31st December 2018 was £6,254 and this has been included as retained earnings brought forward and relates to unrestricted funds. The main difference between the 2019 accounts and the restated 2019 accounts is the income and expenditure for the conferences held, with income into the area accounts amounting to £6,375 and expenditure of £2,761.

Total income for the year ended 31 December 2020 was £38,385, an increase of £5,750 over the previous year. The charity received a legacy of almost £25,000, having received one of £10,000 in 2019. These legacies enabled the charity to continue its work during 2020, when the pandemic has affected the donations and sale of study guides. Expenditure for the year was £, £3,020 less than in 2019.

The charity ended the year with £73,898 cash at bank and in hand.

No reserves policy has been set to date, however, the trustees are committed to the sound financial management of the charity, whilst ensuring that the resources available continue to be invested in providing ways of fulfilling the charity's vision.

STRUCTURE, GOVERNANCE AND MANAGEMENT

We are an evangelical, non-denominational ministry, offering dynamic Bible teaching through Bible study materials, day and weekend conferences as well as area quiet days and outreach events. We are a not for profit organisation. Our leadership structure is as follows:

TRUSTEES who oversee the charity ensuring it complies with its stated aims and objectives. Trustees also ensure financial probity by monitoring the accounts on a regular basis and approving the annual accounts. Trustees set the policies governing the work of the charity. We have had some changes to our Trustees during 2020 as some have retired and others have joined us. We list below the Trustees who were with us at the start of 2020 and those who are now in post.

1 ACCOUNTING POLICIES

(a) **Accounting convention**

(b) **Recognition of incoming resources**

All incoming resources are included in the Statement of Financial Activities when received except for deposits received in respect of future annual conferences. Such receipts are recognised as income of the period in which the event takes place so that total income and expenditure is matched and disclosed in the same period.

(c) **Depreciation of fixed assets**
