Structure, governance and management

The Trust is a registered charity, number 1003520, and is constituted under a Trust Deed dated 23 October 1990.

The Trustees are selected from the membership of Oxford 144 Round Table.

The charity is managed by its members, who meet 4 times per year. There were 11 (2024: 11) members at 31st March 2025.

Objects

The objects of the charity according to its Trust Deed are:

- 1) to relieve persons resident in any part of the world but in particular those resident or temporarily located in the county of Oxfordshire who are in conditions of need, hardship or distress as a result of local, national or international disaster or by reason of their social and economic circumstances;
- 2) to further the education (including social and physical training) of children attending maintained schools in the County of Oxfordshire;
- 3) such other charitable purposes for the general benefit of the inhabitants of the County of Oxfordshire as the Trustees shall think fit.

Means to achieve the objectives for the public benefit

The charity raises finance from fundraising events during the year. The charity received income from these sources of £171,556 (2024: £227,527) and after fundraising costs of £185,015 (2024: £194,504) the charity's funds (decreased)/increased by £(13,459) (2024: £33,023). The charity gave donations of £16,515 (2024: £35,281), spent £224 (2024: £180) on administration costs and received £1,331 (2024: £29) in interest resulting in a deficit of £28,867 (2024: £2,409), which was deducted from reserves. The charity has a grant-making policy of giving to deserving causes in accordance with its objects, in particular to those in the Oxfordshire area.

Financial review

At 31st March 2025 the charity held reserves of £133,201 (2024: £162,068). The Trustees consider that a reserve of at least £125,000 (2024: £125,000) should be held for unforeseen expenditures on its fundraising activities. It is the charity's aim to give as much as possible for charitable purposes. The amount of donations paid in the year was lower than the previous year due to the deficit shown in this year.

Trustees' responsibilities

Charity law requires the Trustees to prepare accounts for each financial period which give a true and fair view of the state of affairs of the charity as at the end of the financial period and of the surplus or deficit of the charity for that period. In preparing those accounts the Trustees are required to:

- Select suitable accounting policies and then apply them consistently.
- Observe the methods and principles in the Charities' SORP 2019 (FRS 102).
- Make judgements and estimates that are reasonable and prudent.
- Follow applicable accounting standards, subject to any material departures disclosed and explained in the accounts.
- Prepare the accounts on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

The Trustees are responsible for keeping proper accounting records which disclose at any time the true financial position of the charity and enable them to ensure that the accounts comply with the Charities Act 2011. The objects of the charity according to its Trust Deed are:

- 1) to relieve persons resident in any part of the world but in particular those resident or temporarily located in the county of Oxfordshire who are in conditions of need, hardship or distress as a result of local, national or international disaster or by reason of their social and economic circumstances;
- 2) to further the education (including social and physical training) of children attending maintained schools in the County of Oxfordshire;
- 3) such other charitable purposes for the general benefit of the inhabitants of the County of Oxfordshire as the Trustees shall think fit.

Means to achieve the objectives for the public benefit

The charity raises finance from fundraising events during the year. The charity received income from these sources of £227,527 (2023: £213,363) and after fundraising costs of £194,504 (2023: £139,875) the charity's funds increased by £33,023 (2023: £73,488). The charity gave donations of £35,281 (2023: £30,907), spent £180 (2023: £175) on administration costs and received £29 in interest resulting in a (deficit)/surplus of £(2,409) (2023: £42,406), which was (deducted from)/added to reserves. The charity has a grant-making policy of giving to deserving causes in accordance with its objects, in particular to those in the Oxfordshire area.

Financial review

At 31st March 2024 the charity held reserves of £162,068 (2023: £164,477). The Trustees consider that a reserve of at least £125,000 (2023: £150,000) should be held for unforeseen expenditures on its fundraising activities. It is the charity's aim to give as much as possible for charitable purposes.

Structure, governance and management

The Trust is a registered charity, number 1003520, and is constituted under a Trust Deed dated 23 October 1990.

Trustees

The Trustees during the year and since the year end were:

Mr Benjamin Burrows
Mr Christian Petersen

The Trustees are selected from the membership of Oxford 144 Round Table.

The charity is managed by its members, who meet 4 times per year. There were 8 (2021: 17) members at 31st March 2022.

Objects

The objects of the charity according to its Trust Deed are:

- 1) to relieve persons resident in any part of the world but in particular those resident or temporarily located in the county of Oxfordshire who are in conditions of need, hardship or distress as a result of local, national or international disaster or by reason of their social and economic circumstances;
- 2) to further the education (including social and physical training) of children attending maintained schools in the County of Oxfordshire;
- 3) such other charitable purposes for the general benefit of the inhabitants of the County of Oxfordshire as the Trustees shall think fit.

Means to achieve the objectives for the public benefit

The charity raises finance from fundraising events during the year. The charity received income from these sources of £197,905 (2021: £2,875) and after fundraising costs of £128,947 (2021: £2,720) the charity's funds increased by £68,958 (2021: £155). The charity gave donations of £24,472 (2021: £5,987) and spent £175 (2021: £395) on administration costs resulting in a surplus/(deficit) of £44,311 (2021: (£6,227)), which was added to/(absorbed by) reserves. The charity has a grant-making policy of giving to deserving causes in accordance with its objects, in particular to those in the Oxfordshire area.

Financial review

At 31st March 2022 the charity held reserves of £122,071 (2021: £77,760). The Trustees consider that a reserve of at least £85,000 (2021: £70,000) should be held for unforeseen expenditures on its fundraising activities. It is the charity's aim to give as much as possible for charitable purposes.

Trustees' responsibilities

Charity law requires the Trustees to prepare accounts for each financial period which give a true and fair view of the state of affairs of the charity as at the end of the financial period and of the surplus or deficit of the charity for that period. In preparing those accounts the Trustees are required to:

- Select suitable accounting policies and then apply them consistently.
- Make judgements and estimates that are reasonable and prudent.
- Follow applicable accounting standards, subject to any material departures disclosed and explained in the accounts.
- Prepare the accounts on the going concern basis unless it is inappropriate to presume that the charity will continue

The Trustees are responsible for keeping proper accounting records which disclose at any time the true financial position of the charity and enable them to ensure that the accounts comply with the Charities Act 2011. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.
