Objectives and activities

The charity has been set up for the relief of sickness and the preservation of health amongst persons residing permanently or temporarily within the catchment area of the surgery by the provision of the medical equipment for medical practices in Bishopsworth.

Achievements and performance

This year has been dominated by an extraordinarily generous legacy from Mr Ernest March. The fund is grateful for his support for the patients of Bishopsworth.

This legacy along with a number of smaller donations from the very kind patients of Grange Road Surgery has enabled the fund to issue two grants to Grange Road Surgery for the provision of equipment upgrades specifically a touchscreen for the surgery waiting room to improve the patient experience and fridges for the treatment rooms to enable better management of patient medication and vaccines.

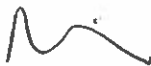
