Having completely refurbished the toilets and installed infrared heating in the previous year, renovations continued this year with the replacement of the windows and new lighting to future-proof the hall and reduce the electricity costs. The trustees plan investment in the hall to keep it in a good state of repair and ensure it attracts a variety of users.

The hall continues to be used by a number of users, predominantly the Pre-school during weekdays and other hires on weekends.
