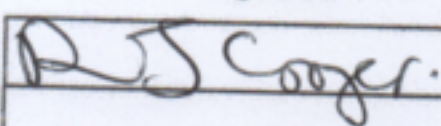

Since recently being asked to carry out an examination I have checked the Charity Commission guidance on the eligibility of the Charity to be the subject of an Independent Examination. On checking the Charity's Trust Deed document I have discovered that a full audit is explicitly stated as being required to be carried out by a fully qualified auditor.

The trustees now have decided, within the last month, that they now wish to amend this document in the near future to require an Independent Examination in future but not a full audit.

Consequently, at this time, I have limited my work to checking the validity of the accounting records and can support the submission of the Receipts and Payments accounts CC16a schedule enclosed here.

The Annual Report submission here is prepared and approved by the trustees, and has not been validated as part of this examination.

Brief statement of the charity's policy on reserves

Following the Trustees' decision on reserves in March 2011, the policy is to maintain reserves of an amount sufficient to pay the current level of assistance for one year ahead (total approx £14,000 in 2023). This is in case of closure of the charity, so that recipients of the Trust's help can have some reassurance that they would continue to be supported for a further year if they qualify.

The Trust's funds are maintained in two bank accounts, a current and a reserve account (interest bearing), held with the National Westminster Bank plc. The total held by the charity at the 2023 year end was £54,410.82.

The main funding for the charity is derived from standing orders from regular donors and from appeals for funds, with the occasional one-off donation. These monies are used to fund the help provided to students at the University in accordance with the key objects of the charity.

This has been an exceptional year in respect of one-off giving (including a bequest) from three individual donors totalling £25,000.

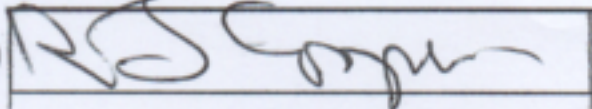

Summary of the main achievements of the charity during the year

The Trust was able to provide support for 15 needy students at the University in 2023. This was done through the award of four bursaries and the Margaret Thomas Scholarship to honours students and 10 meal and book allowances to undergraduates. The sum of £13,648.78 (ZAR315,000) was transferred to the University to fund them.

In 2023, significant events for the Trust were:

- Significant injections of funds from key donors, including late alumni Gwyneth Price and Ralph Bennett.
- Two campaigns appealing for donations to the charity, one in June and one in November, along with circulation of the Trust's summer and winter newsletters. The newsletter and giving form were posted out to about 100 donors in June and about 800 alumni and donors in November. Emails highlighting the publication of the newsletters on the Trust's website were also sent out to alumni in the UK.
- Changes to the board of Trustees during the year: longstanding Trustees Tess Marsh and Colin Morgan stepped down and were thanked for their dedicated service, while two new Trustees were welcomed: Sheralee Ghione and Shaunel Valoshnee Gounden.
