### Independent Examiner's Report to the Trustees of The Crisul Trust

The Independent Examiner reports solely to the Trustees on their examination of the accounts of the Crisul Trust ('the charity') for the year ended 31 March 2022 and which comprise the summary of receipts and payments and the statement of assets and liabilities, in accordance with section 145 of the Charities Act 2011.

Work is undertaken in order to provide an opinion to the charity's Trustees, regarding those matters required and for no other purpose.

#### Responsibilities and basis of report

The Trustees of the charity are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011. This report is in respect of the examination of the charity's accounts carried out under section 145 of the Act and in carrying out the examination the applicable Directions given by the Charity Commission under section 145(5)(b) of the Act have been followed.

An independent examination does not involve gathering all the evidence that would be required in an audit and consequently does not cover all the matters that an auditor considers in giving their opinion on the accounts. The planning and conduct of an audit go beyond the limited assurance that an independent examination can provide. Consequently, no audit opinion is expressed on the accounts and report, which is limited to those specific matters set out in the independent examiner's statement.

#### Independent examiner's statement

I have completed my examination. I confirm that no material matters have come to my attention in connection with the examination giving me cause to believe that in any material respect:

- ▶ accounting records were not kept in respect of the charity as required by section 130 of the Act; or
- ▶ the accounts do not accord with those records.

## CHAIRMAN'S REPORT FOR THE YEAR ENDED 31 MARCH 2022

The Trustees have continued managing the Trust through 2021 and into 2022 focussing on the work in the Churches in the Crisul valley in Romania.

Monthly contributions continued to be received from the 4 individuals and the Church. These totalled £150 each month through the year.

The Trust also receives occasional Collections from Churches and in recent years has developed the general pattern of remitting funds to Romania totalling c.£3k p.a. In these accounts, 2 years' payments are included, i.e. £6k was sent to the churches to fund the Assistant Pastor's salary and other costs, historically the Charity has supported transport and heating costs for the churches and the kindergarten associated with the Hotar church.

The Trustees also became aware of the Churches in the Crisul valley becoming involved in aiding fellow Christians in Ukraine in the build up to Christmas 2021 and funds were sent to Romania on Christmas Eve little knowing that Spring 2022 would bring a very different situation for the Ukrainian people.

Russia's decision to invade Ukraine on 24<sup>th</sup> February led to an appeal for funds to assist Ukrainians who stayed in their own country and those who fled across the borders. By the end of March, the Trust had received donations just short of £4k and the Trustees had made numerous enquiries about how those gifts could best be used.

As always, the key criteria is that the funds will be put to good effect by individuals or organisations who can be trusted and with the minimum administrative overlay. Contact was made with Charities working in Ukraine and the surrounding countries and those working inside Ukraine itself. The Trust also sought to assist those cases where Ukrainians had travelled further afield but where financial assistance was needed. The trustees concluded that the most practical way of helping the Ukrainian refugees was to support financially the considerable work our Romanian partners in the Crisul Valley are doing as they house and care for the refugees that have come to them.


In these accounts, £3,000 has been sent. As at the time of writing that figure has now exceeded £10k.

The Crisul Trust has been able to support the work more generously than it was previously able to do because of a significant legacy it received during the year from a lady who has prayerfully supported the work and shown interest throughout its 30+ years of existence. The Trustees have sought the views of her Executors in coming to a view about what this very generous gift should be used for, and we thank them for their care in helping us to formulate our plans.

The net result of the activities during the year has been a growth in funds of c.£60k to give the Charity a bank balance of £68,314 at the end of March. The Charity owns no other Assets and has no Liabilities.

The Trustees continue to trust God for wisdom and grace as they continue to look for ways of helping our Christian brothers and sisters both in Romania and other countries where we have seen a need for the support that we are able to provide.


