MICHAEL RUSHMERE AS A BUILDING OF HISTORICAL IMPORTANCE OR ARCHITECTURAL VALUE IN THE EVENT OF IT BEING DECLARED REDUNDANT BY A PASTORAL SCHEME MADE UNDER THE PASTORAL MEASURE 1983 OR OTHERWISE CEASING TO BE USED REGULARLY FOR PUBLIC WORSHIP AND THE MONUMENTS FITTINGS FIXTURES STAINED GLASS FURNITURE ORNAMENTS AND CHATTELS IN THE SAID CHURCH AND THE CHURCHYARD BELONGING THERETO
