The playground was finally installed in May after a slight delay and there were no archaeological issues which was very good news. The school now has a fabulous playground and it is proving very popular with the children. This was a large project with a total income raised of £131.7k due to a large number of supporters.

Other items supported include a library upgrade with spend of £2.7k and a pantomime performance for the children. Work was also undertaken on the ongoing sensory garden project.
