## **Trustees annual report**

The "Friends of Pershore Care Centre" was set up as an informal support group in 1987 to help provide equipment for the new care centre in Pershore.

This arrangement was later formalised and set up as a charity and with the aid of a local solicitor, was registered with the Charity Commission. Since then, the "Friends" have provided over £150,000 in physio equipment, wheelchair transport, garden and environmental resources.

We have worked with the local charities to fund our activities.

The Trustees and committee must agree all spending and fund- raising activities and this they do diligently.

## **Accounts**

The accounts are printed and distributed to every member each quarter so that everyone is up to date with activities and can comment on any proposal. Trustees are closely involved with all spending decisions and no wage is paid to any Trustee or committee member.
