REPORT OF THE TRUSTEES FOR THE YEAR ENDED 30 NOVEMBER 2024

GOVERNING DOCUMENT

Standard registration of an unincorporated charity (16 February 1993).

OBJECTIVE AND ACTIVITIES

This building and open space provides opportunities to elderly people and the general public to take part in a range of activities from arts and crafts, amateur sports or science. The objectives of the Charity are to help children and young people with their education by allowing the local school access to the village hall. The Charity is based in rural Herefordshire allowing more people to access facilities within their community.

PUBLIC BENEFIT

In setting our aims and planning our activities the trustees have given careful consideration to the Charity Commission general guidance on public benefit and the PBE provisions of FRS 102.

ACHIEVEMENT AND PERFORMANCE

The village hall has had an decrease in hall bookings, receiving for the year £4,581, an decrease of £2,620 from last year. Pleasingly, there was a large increase in events income totalling £4,224, previous year was £1,646. The charity received one restricted grant: £15,020 from The Estate of Susan Jones to be used for the upkeep and maintenance of the hall.

FINANCIAL REVIEW

The trustees consider that the performance of the charity in 2024 has been satisfactory and has enabled direct charitable expenditure of £10,466 (2023 - £9,566)

The year to 30 November 2024 showed a surplus of £15,638 (2023 - surplus of £6,173)

The trustees believe that existing reserves and incoming resources are sufficient to maintain the objectives of the charity into the foreseeable future.

Investment policy and objectives

The trustees adopt a low risk, secure investment policy whilst aiming to maximise returns.

Reserves Policy

The trustees maintain reserves to balance the fluctuations of both incoming resources and expenditure from one year to another.

RECRUITMENT AND TRAINING OF NEW TRUSTEES

The trustees are recruited for their breadth and depth of knowledge and experience. Trustees are encouraged to undergo training in order to understand their legal obligations under Charity Law. Upon appointment they are briefed on the contents of the Trust deed, the committee and decision making processes and the recent financial performance of the Charity.

RISK MANAGEMENT

The trustees have a duty to identify and review the risks to which the Charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

STATEMENT OF TRUSTEES RESPONSIBILITIES

The trustees are responsible for preparing the Report of the Trustees and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

The law applicable to charities in England and Wales, the Charities Act 2011, Charity (Account and Reports) Regulations 2008 requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources, including the income and expenditure, of the charity for that period. In preparing those financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charity SORP;
- make judgements and estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities Act 2011, the Charity (Accounts and Reports) Regulations 2008 and the provisions of their governing document. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.


