## **Trustees' Annual Report for the period**

### **Background to Trust and Annual Report**

Mayfield Scouts and Guides are one of the oldest continuous groups in the country, having been formed in 1909 by the local Church of England Primary school, with its head master being its first scouts leader.

In 1992 with its hall looking rather dated, and a fire risk, the local supporters committee formed a Charitable Trust with the immediate remit of raising £95,000 to build a modern Scout and Guide hall, on land leased from the Church of England on the original site, adjacent to the school on the edge of Saint George V Recreation Ground, known locally as Court Meadow. It was opened in January 1995.

Today, the Trustees are supported by committee members of the Scouts, Beavers and Brownie packs organisation who add experience to the Trust; something that has proved very successful in that everybody has a position of trust and responsibility; be it running our 100 Club, or taking bookings for our community minibus that the Trust bought and paid for in 2010 after another concerted fundraising effort.

At present over seventy children are members of the Beavers, Brownies and Scouts who directly benefit from the Trust's existence, as well as those community groups who hire the hall when not needed by the Scouts & Guides.

During the pandemic the hall was closed for over fifteen months, bar a one week window in November 2020, which left us with a hall hire of only £108, and in any other year would have resulted in some tough decisions being made; however, this coincided with an electrics grant that we had been working towards since 2018, and Wealden District Council's Covid 19 grant system meant that we received £27,731 in financial assistance. The opportunity was taken to carry out necessary improvement work on the hall during this period with the work on the electrics and replacement of windows in readiness for the reopening of the hall. Equally the minibus has been use to a minimal extent but has continued to be maintained, again in readiness for its use once the restrictions have been lifted.


**Independent examiner's statement**
