TO PROMOTE, MAINTAIN, IMPROVE AND ADVANCE PUBLIC EDUCATION PARTICULARLY BY THE PROMOTION AND ADVANCEMENT OF KNOWLEDGE IN THE FIELD OF ORGANIC/BIODYNAMIC AGRICULTURE AND HORTICULTURE, COUNTRY LIFE AND RELATED SUBJECTS. B. TO PROVIDE OR ASSIST IN THE PROVISION OF FACILITIES FOR RECREATION OR OTHER LEISURE TIME OCCUPATION FOR PERSONS FOR WHOM SUCH FACILITIES ARE PRIMARILY INTENDED BEING PERSONS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABLEMENT, POVERTY OR ECONOMIC CIRCUMSTANCES PROVIDED THAT NEVERTHELESS SUCH FACILITIES SHALL BE AVAILABLE TO THE MEMBERS OF THE PUBLIC AT LARGE.

**Activities:** Provide a therapeutic working environment for adults with special needs who use the Day Centre or visit the farm for activities with their carers. Educational activities on horticulture and livestock production. Engaging with schools, college and children through courses and activities. Provide opportunities for volunteers, young people and those seeking employment, to participate in farm activities.
