TRUSTEES REPORT

The trustees present their report and accounts for the year ended 31 December 2020.

Objects and Activities

To promote the development of young people in achieving their full physical, intellectual, social and spiritual potentials as individuals as responsible citizens and as members of their local, national and international communities.

The method of achieving the aim of the association is by providing an enjoyable and attractive scheme of progressive training based on the Scout promise and law and guided by adult leadership.

Summary of activities performed this year

The following summary shows how the charity has met the requirement to deliver public benefit.

4th Chandlers Ford Scouts, Cubs and Beavers had a mixed program of activities during 2020 that was significantly impacted by the Covid19 lockdowns in the year. In line with UK Scouting and Government guidelines face to face scouting had to be suspended during the lockdowns. Where possible, unit leaders moved the scouting experience online through leading virtual zoom meetings. Diverse activities that included cooking lessons, online games, model making, camp at home activities and talks & informative sessions were undertaken each week. When lockdown restrictions were not in place, outdoor activities were put on including spending time at the district campsite, undertaking local hikes and orienteering and visits to local climbing centres.

Utilisation of the Scout HQ building was also impacted by the national lockdowns. The building being shut for a significant period of the year. When available, the hall is now used by District Explorer Scouts, an after-school club, a dance club and is also available for hire for events and parties.

2020 Accounts and Financial Review

The trustees report a net income for the year of £9,323 after allowing for depreciation. The Designated Funds, £65,172 covers large assets and longer-term costs. The remaining general fund balance of £11,632 is at the target range and the trustees continue to keep this under close review.

The trustees are satisfied that the reserves held in Designated Funds and Undesignated Funds are sufficient to enable the charity to continue to fulfil its charitable objectives for the foreseeable future.

In response to the first lockdown and the loss of income for the group, we were informed by our District team that we could be eligible for a government grant, the group therefore applied for a relief grant from Eastleigh Borough Council. A grant of £10,000 was received in 2020. This money has been invaluable in addressing the impact of all three lockdowns in 2020 and 2021 to date. After accounting for the grant, total income still fell 5% year on year. Fundraising income fell by 65% and direct section income by 93%. Collection of subscriptions grew by 4% as a result of the increase in subs agreed in 2019. Subscriptions were collected in early 2020 before the March lockdown therefore were not impacted. At the end of 2020, the committee reassessed the subscription policy and have moved to a termly approach in 2021 to better allow us to address the ever-moving situation on what scouting activity can be provided.

2020 Accounts and Financial Review (continued)

Due to the lower rental income expected through 2020 and beyond, the Executive Committee agreed to increase the subscriptions in 2020. The 4th Scout group has been able to maintain historical very low subscriptions with no annual increases in the recent past, therefore even with this increase, the subscription remains good value for the parents and carers of those attending the group. Hourly hall rental rates have also been increased.

With the unknown caused by the lockdown, the executive committee agreed to minimise expenditure early in 2020. Expenses reduced 42% YoY, mainly due to the closure of the hall for a significant period of the year. Utilities cost reducing by 44%, Maintenance/Cleaning by 55% and Section expenses by 82%.

At the end of 2020, we were approach by our district team and the 2nd Chandlers Ford scout group concerning financial assistance towards the re-build of their hall. After careful consideration of our financial position moving into 2021, balanced with our support of the local scouting district, the executive committee agreed to provide a donation of £5,000 in 2021. A designated fund has been set up to cover this donation.

Concerning 2021, the executive committee continue to balance the provision of charitable scouting services to our local community with the local and national restrictions in place. The Covid grant allowed us to undertake the necessary expenditure to bring the hall back into use for our two main renters and to re-assess the subscriptions of our membership. We will continue to be guided by UK Scouting and our District and County teams.

Basis of independent examiner's report



NOTES TO THE ACCOUNTS 31 DECEMBER 20 20

1 ACCOUNTING POLICIES

(a) Accounting convention

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) - (Charities SORP (FRS 102)).

The charity meets the definition of the public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

The accounts have been prepared on the going concern basis. There are no material uncertainties about the charity's ability to continue.

(b) Funds

- Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.
- Restricted funds are subjected to restrictions on their expenditure imposed by the donor.

(c) Income

All income is included in the Statement of Financial Activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Donations and legacies are received by way of grants, donations, legacies and gifts and is included in full in the Statement of Financial Activities when receivable. Grants, when entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.

Investment income is included when receivable.

Income is deferred when, at the end of an accounting period, they have been received but the charity has yet to become unconditionally entitled to them.

(d) Expenditure

Expenditure is recognised on an accrual basis as a liability is incurred. It includes any VAT paid.

Costs are apportioned in line with the income received from that source during the year.

Charitable activities expenditure comprises of those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

All costs are allocated between the expenditure categories of the Statement of Financial Activities on a basis designed to reflect the use of the resource. Costs relating to a particular activity are allocated directly.

(e) Fixed assets

Fixed assets are capitalised for ongoing use within the company, where the individual cost of the asset exceeds £100.

Depreciation is provided on fixed assets to spread the cost over the estimated useful lives of the relevant assets at the following rates:

Heating System	10% Straight line

Policy and Notes

Unrestricted Funds are working funds used throughout the year and help fund HQ maintenance projects. They also help mitigate risk if income drops (for example in 2011 when HQ Hall Booking revenue dropped significantly). The objective is to maintain a reasonable level of Unrestricted Funds to address future fluctuations in income and expense.

The target amount for Unrestricted funds is £10,000 and upper limit set to £15,000. Typically HQ Maintenance projects are funded or not during the year to manage the unrestricted fund within the agreed limits.

The target of £10,000 will cope with approximately 1 year of lost income associated with HQ Booking and will cover yearly expenses for Utilities, HQ Insurance, Maintenance and Cleaning in case of emergency.

The risk of a drop in Subscriptions or Section Income is considered low and no accommodation is needed for these.

In light of the various restrictions in place due to the Covid-19 Pandemic, the hall has been out of use during the national lockdowns. The government grant coupled with the expense restrictions implemented has allowed us to maintain a good financial position. The unrestricted funding for 2021 is deemed to remain sufficient.
