In order to fulfil the duties under the Charities Act 2011, the Receipts and Payments account of the Crynant Community Association have been prepared as directed by the Trustees. We declare that the Crynant Community Association has kept proper accounting records and the Receipts and Payments account gives a true and fair view under the Charities Act 2011. It is considered that the Crynant Community Association is exempt from the statutory requirement for an audit this year.

Report to the Trustees of Crynant Community Association.

The usual activities for the Association have ceased as a result of the Coronavirus pandemic. During these difficult times we continue to operate when permitted, within government guidelines.

We have, however, had to adapt the way we provide our core activities to remain within the purpose of the charity - to promote and facilitate wellbeing - Health, Social and economic care for the general public.

Prior to the pandemic, the revenue of c£6k from the room hire of the Community Centre was sufficiently small as to require a minimal level of governance and financial management .

Income this year has increased as a result of four (2 x NPT business rate & 2 x WCVS) Covid related grants in the sum of £37,154 and a further grant from the Ford Community Fund in the sum of £19,985. This totals £57,139.

The receipt of the grant funding has allowed the Association to shift the focus of its activities from indoor (hall hire) to outdoor activities. A large portion of the grants received will be used to improve our outdoor facilities. We have been fortunate enough to be able to provide outdoor gym equipment, upgrade our BMX track to a pump track, provide temporary buildings for use as the 'Sharing Shed', and space for volunteers to meet.

When guidelines allow, the Association will be better placed to provide activities inside the Community Centre. We will improve our digital offering, reconfigure the gymnasium and provide classes and activities rather than rely on private hire. The funding will allow us to do this safely by providing screens, hand sanitising, signage and advice.


The Charity does not pay expenses or make payments to Trustees.


As soon as restrictions allow, a meeting will be convened, at which a review will be conducted and an independent examiner appointed.
