Activities: The provision of facilities and funding to enable young people to play hockey or other games or sports in order to assist in their physical education and the development and occupation of their minds. Also the provision or assistance in the provision of facilities for recreation or leisure time for the benefit of the general public or others who by reason of age, or infirmity need such facilities.
