The object of the charity is to provide a public ground for the purposes of the Recreation Grounds Act 1859. The charity provides a playing field and pavilion for use by cricket and football clubs from the village of Newborough and immediate locality.


The charity is administered and managed by the trustees, subject to and in conformity with the provisions of the scheme and such services provided by the trustees are made on a voluntary basis. The power to appoint new trustees is vested in the existing trustees. When new trustees are appointed they are given an overview of the charity and an outline of both its operational and financial activities. New trustees are selected in order to gain benefit from their skills and experience, to complement the existing trustees, and to provide succession.

The trustees can report that the management of the charity was in their opinion completed on a satisfactory basis during the year. The trustees have considered the guidelines issued by the Charity Commission on public benefit and are of the opinion that the criteria are being met within the objectives and activities of the charity.

Review of the year

During the year the charity received a legacy payment of £221,592.54 which will fund the future costs of maintenance and upkeep of playing fields. A second restart grant from Peterborough City Council, as a result of the Covid-19 pandemic, has also been received during the year.

The financial position of the charity at 31 March 2022 is considered satisfactory and more than adequate to meet the objectives of the charity. The charity does not have a specific policy on reserves. The trustees ensure the charity does not enter into any commitment it is unable to fulfil.

During 2021 a lawn mower and storage container were purchased at a total cost of £6,900.

During the current year an artificial cricket wicket and storage container were purchased, and a new septic tank was installed, costing a total of £14,004.21.
