ANNUAL REPORT

FOR YEAR ENDED 31ST MAY 2023

The Preservation Trust launched a Preservation Appeal to raise funds for the preservation of the All Saints Church Tower.

The appeal was launched April 2022 with the aim of raising £75000.

The appeal raised £66406 during the year from 31st May 2022 to 31st May 2023, on track to raise the target. The income was mainly raised from a combination of:

- Individual donors
- Foundations – Valiant Trust, Benefact and Mercers
- Legacy
- Several concerts and the Auction of Promises

The planned preservation work consists of several main components:


- Repointing both sides of the 4 large buttresses from the base to the top
- Repointing of the top quarter of the tower walls around the belfry and the battlements and about half of the remaining wall faces
- Replacing many of the structural clunch stones
- Restoring the stone work around the windows and tower door
- Removing and repainting the iron down pipes
- Replacing some of the tower windows.

The work is scheduled to be undertaken in Summer 2023


