1st Fordingbridge Scout Group provides Scouting related activities and opportunities to approximately 70 young people between the ages of 4 and 14 years old. Our young people are supported by 26 adult volunteers.

The Group's income and expenditure is small. The Group has adopted a low risk strategy and all funds are held in cash at Lloyds Bank.
