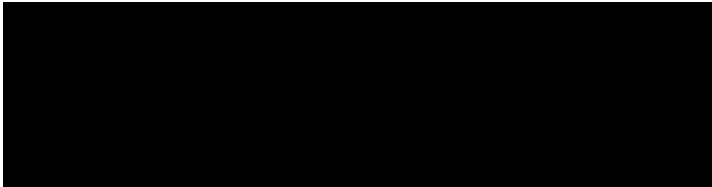

I report on the accounts of the Group/District for the year ended 31st March 2024.
