Treasurer's Report
AGM
Monday 25th September 2023

The BSA started the year with a healthy bank balance to support of fundraising activities for the year.

Through a combination of well-established events, new initiatives and passive income we raised over £21,000.

Our most profitable events were:

- Fireworks over £10,500 profit
- 3 x School Discos over £3,600 profit
- Summer and Christmas Fairs over £3,300 profit

We reintroduced Bingo night, trialled a successful pizza night, were overwhelmed with orders for our year group tea towels, which was our mother's day fundraiser and saw a steady stream of income from our online 2nd hand uniform sales.

Profit for each event is itemised on the attached sheet.

This year we were able to make several gifts to the pupils of the school including bookmarks to commemorate the Coronation, a pantomime and as in traditional, a gift from the BSA to the year 6 leavers.

The main purpose of our fundraising each year is, of course, to support the school and we are pleased to report that this year we were able to donate just over £22,000 which will be used towards various projects including building work, new Chromebooks, new dictionaries, a greenhouse and storage facilities.

Our passive income this year was just over £230, this should be an area for focus in the future, especially given the end of the Amazon Smile programme which brought in the majority of this funding.

We are ending the year with a healthy reserve in the bank and in petty cash ready for the work of the year ahead.
