

The trustees have assisted our members to start up five new groups last year: Summer Evening Walks; Sewing, Crochet &amp; Knitting; the Jazz &amp; Blues Group; a discussion group and our very first group that uses Social Media to operate – Photographs on Facebook. The initial start-up costs for several of these groups were met from our reserves.</b></p> <p><b>The Trustees also consider it is important to engage with new members within 6 months of them joining, in order that they feel both welcome and valued. With this in mind two 'New Members' meetings were arranged last year, one in May and the other in November. 
