REPORT FOR THE YEAR ENDED 31st DECEMBER 2021

The League of Friends was founded in October 1953, and is a registered Charity, number 1027400. It is operated in accordance with a Constitution, the latest revised version of which was approved on 3rd August 2019. The League is affiliated to ATTEND.

The Constitution sets out the objectives, the foremost of which includes the encouragement of the interest of the public in the patients of Warwick Hospital, and the raising of funds for the benefit or welfare of the patients and staff or to supplement the resources of the hospital service.

A Committee of Trustees conduct the affairs of the League not less than five nor more than twenty-five in number, appointed at the Annual General Meeting.

Reserves Policy

The policy of the Trustees is to maintain sufficient reserves for the long-term stability of the charity (three to five years). This is to ensure ongoing commitments can be fulfilled, whilst maintaining a realistic level of reserves to provide for fluctuations in requests made to the Warwick Hospital League of Friends. This would be financed from within the Unrestricted Funds.

The current level of resources can be broken down as follows:

1. Restricted Funds are currently £164,410 (64.5%) of the charity's finances. This relates to a nurse's prize fund (£6,501), where dividends earned are used to finance awarded prizes.
In addition, the charity has received a legacy £155,909, which is earmarked to haematology services.
2. Unrestricted Funds
The remaining unrestricted balance goes towards supported grants for any service area or patient support within the hospital. This relates to £89,488 (35.5%) of the charity's finances.

The budgetary process of the Trustees is to formally approve projects and their financial consequences as they are proposed. Consequently, there is ongoing budgetary control by the Trustees to ensure no project would be approved that would impact upon its ongoing financial stability, in line with this Policy.

Activity During Year

The ongoing pandemic which has brought further lockdown periods and continued restrictions in terms of fund-raising activity by Trust volunteers within the hospital. A typical year pre pandemic at the Trust's hospital shops (Bric a Brac and Book shops) would have raised in the region of £8,500. Due to the understandable safety controls within the hospital, there has been no shop activity allowed this year. Consequently, donations and collections alone have raised £2,197 throughout the year. However, the Trust has received a number of legacies this year which has provided some financial stability for the immediate future.

In 2021 a total of £161,203 was raised, the most significant element was from legacy receipts of £158,741 (Notes 2b and 5). There were grant payments totalling £5,130 (Note 4), the main expenditure of which was for continuing to provide Courtesy packs for patients and an Ice Cream event for all Hospital Staff as a thank you for their continuing demanding work and commitment during these very difficult times.

Restricted and Unrestricted Funds raised, and monies spent are detailed in notes 2 to 5 to the accounts. The year ended with a balance of £251,898 of all funds, an increase of £155,347 from 2020. The increase in funds reflected the legacy receipts mentioned above.

The level of donations and collections for 2021 of £2,197 is a mirror of 2020 - £1,956 (excluding the income from the hospital Shops in 2020). Although this is a diminished level compared to previous years there are still notable contributions such as from the Stoneleigh United Charity,

collection tins and individual donations in memory of people who sadly passed away, which included Mr Roy Joyner, a previous chairman and long-standing Trustee to the Warwick Hospital League of Friends Organisation.

The 67th Annual Report and Statement can be seen on pages 5 to 10.

The total amount of money which the League has raised since its inception sixty-seven years ago is £1,666,510.

Should any member of the public wish to have any further information about the activities of the League, the Trustees will be pleased to supply additional detail.


Future Activity

The receipts received especially during 2021 has given the League of Friends of Warwick Hospital a level of financial stability for the immediate future. Consequently, the Trust has been proactive in contacting wards throughout the hospital asking whether they have any priority requirements. A number of purchases / schemes over five wards have been approved totalling approximately £12,000 whilst three other schemes are still being costed or reviewed.

In addition, over 2022 it is planned to engage with the hospital regarding how the League of Friends can be involved with any haematology schemes / projects.



REPORT OF THE HONORARY INDEPENDENT EXAMINER

to the Trustees of the League of Friends of Warwick Hospital Charity No 1027400

I report on the accounts of the League of Friends of Warwick Hospital for the year ended 31 December 2021, which are set out on pages 5 to 10.

Respective responsibilities of Trustees and Examiner

The Charity's Trustees are responsible for the preparation of the accounts.

The Charity's Trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 (the Charities Act) and that an independent examination is needed.
