Coronavirus. We remained open throughout for vulnerable children and children of key workers. Initially only 2 children used us but after the Easter holidays this went up to 3 and we now have 8 (including one 'new' child who joined us)

We will start with 11 children this September with another to start later that month when they have their second birthday.

There is also another child who will be due to start with us after Christmas so numbers dont look too bad. We are hoping to be able to run wrap around but need the guidance to come out to confirm that this is possible, many parents have already requested this for when school is back open fully. ✪

Topics covered through this year were: transport, minibeasts, autumn/halloween (we had a small in-setting party), space, Xmas, reading around the world and we had just begun spring (we hatched chicks, turned caterpillars into butterflies and frogspawn hatched but was released as tadpoles) when we had to close. We also did Remembrance Day and Bonfire night activities.

Pre coronavirus we have continued to partake in regular Welly Wednesday sessions with reception. In September we had a yoga teacher, Claire, visit once a week. After October half term we had Kirsty (who used to come in a few years back) once a week for movement and music sessions-she was very popular. We had also been doing Puppet, Prayer and Praise sessions on the first Tuesday of the month, with Reverend
