Structure, governance and management

The Fund was registered as constituted by a Trust Deed dated 8 November 1993 and was registered as a charity on 29 November 1993.

The trustees are appointed by the members of the Rotary Club of Windsor St. George at a general meeting and are given such induction as is considered necessary in order for them to understand the requirements of charity law and perform their duties effectively.

Details of the trustees during the year and any subsequent changes are given on the reference and administrative details page 3.

The trustees do not believe that there are any significant risks to which the charity is exposed. For any event that is organised by the Rotary Club of Windsor St. George, a risk assessment is performed and budget prepared when planning the event. Any other risks that arise are managed at the monthly meeting of the trustees or by the committees of the Rotary Club.

Objects and activities

The objects of the charity are: the relief of the poor and needy and such other charitable institutions, societies and objects as the club shall, in duly constituted meeting, from time to time direct.

Funds are raised by members of the club in various ways and distributed to the beneficiaries recommended by the Rotary Club of Windsor St. George's committees and membership.

The main activity undertaken for the public benefit in relation to the charity's objects is the making of grants. The trustees have had regard to the guidance issued by the Charity Commission on public benefit.

Achievements, performance and financial review

The charity's major fundraising events and activities during the year were:

- Christmas Carol concert
- Murder Mystery event
- Grant for a Repair Café
- Donations from members of the public
- Legacy from a former honorary member

The total income raised during the year was £33,251 (2023: £5,614).

The charity spent £17,612 (2023: £4,573) in grants during the year. These payments covered a wide range of worthy causes in response to both crises and longer term needs locally, nationally and internationally.

The charity had general reserves as at 30 June 2024 of £8,097 (2023: £5,045) as well as designated funds of £5,000. During the year, the trustees kept the reserves policy under review and continued to determine that the charity will aim to maintain £2,000 in general funds to cover future expenditure.

- Covid-19 Meal Pledges (in lieu of cost of meals at club meetings)
- Member & supporter donations
- Louis Baylis Trust grant
- 2021/22 steam train event advance ticket sales
- Foreign currency collections.

Normally other fundraising events undertaken during the year include raffles and sponsored events but Covid-19 lockdowns and restrictions precluded these and the possibility of other new and annual events.

The total income raised during the year was £25,206 which included advance ticket sales of £17,204 for a steam train event in 2021-22 (2020: £5,128).

The charity spent £7,993 (2020: £5,932) in grants during the year. These payments covered a wide range of worthy causes in response to both crises and longer term needs locally, nationally and internationally.

The charity had general reserves as at 30 June 2021 of £1,907 (2020: £1,724). During the year, the trustees kept the reserves policy under review and continued to determine that the charity will aim to maintain £2,000 in general funds to cover future expenditure.


