## Annual Report for the year ended 31 March 2025

### Reference and administrative details including Structure, Governance and Management

Hallaton Church Restoration Trust (“the Charity”) is constituted by Deed of Trust and is registered with the Charity Commissioners (No. 1029595).

The Charity’s principal address is 7 Eastgate, Hallaton, Market Harborough, Leicestershire, LE16 8UG.

The Charity is administered and managed, in accordance with its Trust Deed, by Trustees. The following served during the year:

Trustees are selected from the congregation of the Church and all new Trustees undergo a briefing on: their legal obligations under charity law; the content of the Trust Deed, the management and decision making process; the recent financial performance of the charity; and its future cash flow and other business plans. Trustees are encouraged to attend appropriate external training events where these will facilitate the undertaking of their role.

### Objectives and Activities

The object of the Charity is the restoration and future maintenance of the Parish Church building known as St. Michael and All Angels, together with its churchyard and churchyard wall, situated in Hallaton, Leicestershire.

The Trustees work closely with the P.C.C. and appropriate professional advisers to identify such restoration and maintenance projects and, where they consider it to be appropriate and of public benefit, they will commission the work or make grants to finance an agreed proportion of the costs.

The Trustees confirm that they have referred to the guidance in the Charity Commission’s general guidance on public benefit when reviewing the charity’s aims and objectives and in planning future activities.

### Financial Review, Achievements & Performance

The attached financial accounts are presented on a receipts and payments basis, which is a factual record of the money received and paid by the Charity during the financial year. This basis, which has been consistently applied from one year to the next, is considered to be the most appropriate for unincorporated Charities with an annual income of less than £250,000. A separate Statement of Assets and Liabilities, listing the significant possessions and outstanding financial commitments of the Charity, at the end of the financial year is also included.

The accounts also comply with the appropriate legal requirements and pronouncements made by the Charity Commission.

This has been a busy year for the Trust. As in previous years, it participated in the Leicestershire Festival of Archaeology, which comprised of a number of invited speaker events over several weekends, video and static displays on St Morrell and pilgrimage, and their links with the church, Bottle Kicking and the Hare Pie Scramble.

The Trust secured a grant of £20,000 from the Government’s Rural Grant Fund, which was used to renew and improve the church’s electrical installation and to purchase new catering equipment for St Morrell Café. The café, which is held weekly in the church, has become a social hub for the village.

### Financial Review, Achievements & Performance (continued)

In addition, the Trust secured a Faculty (Church of England consent) to remove the fixed pews in the north aisle and make good the wooden floor, creating a flexible space for exhibitions and church uses. This also serves as preparatory stage works for the crypt restoration project.

The Charity's gross receipts for the year were £27,694 compared with £2,251 in the previous year. Of this sum £940 related to voluntary donations from individuals and £25,520 related to grants from Harborough District Council, Hallaton Parish Council, Hallaton PCC and the Listed Places of Worship Grant Scheme.

Receipts from fundraising events totalled £1,042, all of which came from events held as part of the Leicestershire Festival of Archaeology and the remaining £192 was interest received on money held on deposit.

Expenditure in the year amounted to £27,604, of which £369 was spent on fundraising activities and £792 on assets that have been retained for future fundraising events.

### Reserves

As a result of the transactions described above the Charity's receipts exceeded its payments for the year by £90.

This surplus has been added to the cash reserves brought forward which, as a consequence, have increased to £17,409 at 31 March 2025, including £826 related to the restricted fund for St Morrell's chapel. The Trustees believe that these reserves are required to enable the Charity to make further meaningful contributions to the restoration and upkeep of the Church and Churchyard, as need arises, over the next few years.

### Trustee Remuneration

No remuneration was paid to Trustees and there is no Trustee Indemnity Insurance in place.



As the charity's trustees you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').


