TO SUPPORT THE GREENFIELDS COMMUNITY CENTRE AND TO MAINTAIN AND MANAGE OR TO CO-OPERATE WITH ANY STATUTORY AUTHORITY IN THE MAINTENANCE AND MANAGEMENT OF SUCH A CENTRE FOR ACTIVITIES PROMOTED BY THE COMMITTEE AND ITS CONSTITUTENT BODIES.

It manages a community centre to provide facilities in the interest of social welfare for recreation and leisure-time occupations with the object of improving the conditions of life for the said residents.
