2. Structure, Governance and Management

The Charity is an unincorporated association which is managed by up to eleven committee members (Charity Trustees) who are residents of the Parish of South Warnborough. Committee members are elected annually. New members are elected by simple majority of the committee. The committee votes to appoint its chairman and other officers, and to determine the signatories for the charity bank accounts. The committee meets every three months. A written agenda and minutes are circulated. All significant issues are decided by a majority vote of the committee members at the meeting. The committee may delegate to a sub-committee particular responsibility for a specific activity. All meetings are open to the public and local residents are particularly encouraged to attend the Annual General Meeting. The management committee may invite the Parish Council to nominate a representative member of the committee.

The Charity was formed in 1926 and governed by the 'Original Trust Deed' dated 6 December 1926. This Trust Deed was superseded by a Deed of Trust dated 7 October 2010 at which time the name of the Charity was changed from South Warnborough Village Hall to The Ridley Hall, South Warnborough. The new document was designed to clarify and broaden the terms of the original document and not to reduce any responsibilities or powers of the trustees set out in it. In particular the trustees may distribute surplus funds to an appropriate activity in the parish consistent with the objects of the charity.

The freehold interest in the land and buildings was vested in the Charity Commission in 1997 for legal convenience. The Commission would be required to agree any sale or financial encumbrance of the property.

3. Financial Review

COVID-19 Pandemic

Due to the continuing COVID-19 pandemic the hall was closed from December 26th 2020 until 12th April 2021. The Hall received government support grants totalling £16,573 (2020: £11,334).

3.1 General Income

Income from hire of hall increased to £4,939 (2020: £3,732). Fundraising income from Film Nights was £452 (2020: £467). As last year only 2 films, out of a normal 12, were shown due to closure and social distancing limitations.

3.2 General Expenditure:

Hall expenses excluding depreciation were £7,651 (2020: £8,692). Our main regular expenses are cleaning, maintenance and landscaping. General repairs included painting and repair to external rendering. Landscaping and maintenance of the bank and car park continues. Depreciation charge for the year was £1,380 (2020: £2,632). The decrease was due to some fixtures and fittings being fully depreciated in 2020. The old water softener, having been purchased on 2007, was replaced at a cost of £1,110.

3.3 Gables flat Income:

We have extended the contract with our tenant for a further 3 years to December 2024. The flat provided an income of £9,008 (2020: £8,398).

3.4 Gables flat Expenditure:

Maintenance costs £1,078 (2020: £3,271) included those associated with the start of a programme to improve the energy efficiency and reduce the carbon footprint of the flat. These were a heat loss survey and increased loft insulation

4. Reserves Policy

In order to maintain the smooth running of the hall, the Trustees aim to retain cash reserves at least equivalent to twelve months' normal expenditure.

5. Public Benefit

The Charity aims to provide village hall facilities for hire primarily, but not exclusively, to the residents of South Warnborough. The management committee ensures that the facilities are available to all and are maintained in a suitable state of repair and suitably insured against risks including fire, theft and public liability. The facilities are available to the public for the promotion of arts, culture, heritage, science, sport, recreation and education.

6. Objectives and Activities

The objectives of the charity are the provision of a village hall, the advancement of education and the provision, in the interest of social welfare, of facilities for recreation and leisure time occupation.

7. Achievements and Performance

After a lengthy period of closure, the hall reopened in April and has remained open since.

We have continued with our social distancing, ventilation requirements and cleaning regimes which have encouraged our hirers to return to previous levels of activity.

Our activities include Pilates, Yoga, Ballet, Art, Bridge, Personal Training, Parish Council Meetings, Youth Group, Adult and Children's gatherings and parties.

Although our January Film Night was cancelled, the February film is planned to go ahead and we hope to continue a monthly showing as long as the COVID 19 situation remains stable.

With funds available we set up a sub-committee to investigate potential energy saving and carbon reduction opportunities:

i) The Gables flat.

A Heat Loss Survey was commissioned. The recommendations of the report were to increase insulation in the loft area and investigate the possibility of installing a heat pump similar to those installed in the main hall in 2014. The insulation work has been carried out and preparation for the heat pump installation has commenced. The heat pump will be installed as soon as equipment and fitters are available, the delay being due to high demand.

ii) Photo Voltaic Cells and Batteries

After an accurate survey of the roof, we have provisionally accepted a quotation for the installation of PV cells, inverter and batteries to supply solar power to the hall and any excess to the grid. In order to go ahead we need our energy supplier to update our meters to smart meters and our grid operator to give their agreement. Installation will follow.

- to state whether particular matters have come to my attention.


Basis of Independent Examiner's statement


Independent Examiner's statement

In connection with my examination, no matter has come to my attention:



Notes to the Accounts:

1 Basis of Preparation

1.1 Basis of Accounting

These accounts have been prepared on the basis of historic cost in accordance with:

- Accounting and Reporting by Charities Statement of Recommended Practice (SORP 2019) and FRS 102;
- the concessions for small unincorporated charities not subject to statutory audit, in particular analysis based on the nature of income and expenditure;

2 Accounting Policies

2.1 Incoming Resources

Recognition of incoming funds

These are included in the Statement of Financial Activities (SoFA) when the charity becomes entitled to them.

2.2 Expenditure and Liabilities

Liability recognition

Liabilities and related expenditure are recognised as soon as there is a legal obligation committing the charity to pay.

Governance costs

None of the Trustees receives any payment or reimbursement of expenses.

2.3 Assets

Tangible fixed assets for use by the charity

These are capitalised if they can be used for more than one year, and cost at least £500. They are valued at historical cost.

Freehold land & buildings are not depreciated. Fixtures & fittings and electronic equipment are depreciated over 10 years and 3 years respectively.
