Objects: THE RELIEF OR PERSONS WITH LEARNING DISABILITIES AND/OR MENTAL HANDICAP WHO ARE OR HAVE BEEN AT ANY TIME RESIDENT IN THE ISLE OF WIGHT PARTICULARLY BY THE PROVISION OF RESIDENTIAL CARE AND BY MAKING FINANCIAL GRANTS OR LOANS (INCLUDING THE LOANS OF CHATTELS OR PROPERTY) ON SUCH TERMS AS THE TRUSTEES THINK FIT TO: (A) TO SUCH PERSONS EITHER COLLECTIVELY OR INDIVIDUALLY (B) FAIRHAVEN HOUSING PART OF ISLE OF WIGHT SOCIETY OR ANY OTHER CHARITABLE ORGANISATION PROVIDING CARE AND SUPPORT FOR ANY SUCH PERSON (C) ANY OTHER PERSON OR BODY PROVIDING CARE OR SUPPORT FOR ANY SUCH PERSON.
