Objectives and Activities

The objectives of the charity remain:

- To maintain the premises of Astley Burf as a school camp for the benefit of children and young persons of the Borough of Dudley;
- To administer the assets and liabilities of the camp and
- To permit Dudley Metropolitan Borough Council's Regeneration & Enterprise Directorate Management Team (DMT) to allow people to have full use and occupation of the premises for the purposes of a camp for children and young persons.

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

Achievements and Performance

Astley Burf Outdoor Education Centre was open for the period 1/4/24 – 31/3/25. The main income received was from lettings and other sales as well as the Council as a contribution to the costs of maintenance of grounds and property.

Significant items of expenditure during the financial year include staff pay and premises related costs such as heating and lighting. Other significant expenditure was repairs to the high ropes course and adventure playground plus tree inspection and remedial works required.

In terms of school visits, the centre was booked for 118 days with 1,251 children attending in the period, of which 322 were eligible for free school meals and therefore not charged for food and accommodation.

Financial Review

The Charity has received income in the financial year from lettings and sale of souvenirs £141,347. It has also received income from Council support of £87,502.

.

This has met the costs in the financial year of £228,849 incurred on delivering the service to the children including maintenance of grounds and property.

The Charity does not hold reserves. If income received from lettings or other income relating to the premises is not sufficient to meet the costs of providing the service, the Council will make the required contribution to break even in the year.

The property is currently valued at £1,313,334. It was revalued in 2025.

The Charity currently has no investments.

Structure, Governance and Management

The charity was established in 1938 by Deed of Gift and is registered with the Charity Commissioners (No 1037595).

The Trustee of the Charity is Dudley Metropolitan Borough Council.

Objectives and Activities

The objectives of the charity remain:

- To maintain the premises of Astley Burf as a school camp for the benefit of children and young persons of the Borough of Dudley;
- To administer the assets and liabilities of the camp and
- To permit Dudley Metropolitan Borough Council's Regeneration & Enterprise Directorate Management Team (DMT) to allow people to have full use and occupation of the premises for the purposes of a camp for children and young persons.

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

Achievements and Performance

Astley Burf Outdoor Education Centre was open for the period 1/4/23 – 31/3/24. The main income received was from lettings and other sales as well as the Council as a contribution to the costs of maintenance of grounds and property.

Significant items of expenditure during the financial year include staff pay and premises related costs such as heating and lighting. Other significant expenditure was repairs to the high ropes course and adventure playground plus tree inspection and remedial works required.

In terms of school visits, the centre was booked for 118 days with 1,266 children attending in the period, of which 271 were eligible for free school meals and therefore not charged for food and accommodation.

Financial Review

The Charity has received income in the financial year from lettings and sale of souvenirs £129,567. It has also received income from Council support of £100,445.

.

This has met the costs in the financial year of £230,012 incurred on delivering the service to the children including maintenance of grounds and property.

The Charity does not hold reserves. If income received from lettings or other income relating to the premises is not sufficient to meet the costs of providing the service, the Council will make the required contribution to break even in the year.

The property is currently valued at £200,000. It was revalued in 2020.

The Charity currently has no investments.

Structure, Governance and Management

The charity was established in 1938 by Deed of Gift and is registered with the Charity Commissioners (No 1037595).

The Trustee of the Charity is Dudley Metropolitan Borough Council.

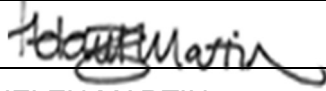

The objectives of the charity remain:

- To maintain the premises of Astley Burf as a school camp for the benefit of children and young persons of the Borough of Dudley;
- To administer the assets and liabilities of the camp and
- To permit Dudley Metropolitan Borough Council's Regeneration & Enterprise Directorate Management Team (DMT) to allow people to have full use and occupation of the premises for the purposes of a camp for children and young persons.

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

Achievements and Performance

Due to the Covid19 pandemic the Astley Burf Outdoor Education Centre was closed for the period 1/4/21 – 14/2/22. As a result, the main income received was from the Council as a contribution to the costs of maintenance of grounds and property.

Significant items of expenditure during the financial year include staff pay and premises related costs such as heating and lighting.

In terms of school visits, 217 children attended the activity centre in the period as a result of the site's closure for most of the financial year.

Financial Review

The Charity has received income in the financial year from lettings and sale of souvenirs £18,316. It has also received income from Council support of £141,186

.

This has met the costs in the financial year of £159,502 incurred on delivering the service to the children including maintenance of grounds and property.

The Charity does not hold reserves. If income received from lettings or other income relating to the premises is not sufficient to meet the costs of providing the service, the Council will make the required contribution to break even in the year.

The property is currently valued at £200,000. It was revalued in 2020.

The Charity currently has no investments.

Structure, Governance and Management

The charity was established in 1938 by Deed of Gift and is registered with the Charity Commissioners (No 1037595).

The Trustee of the Charity is Dudley Metropolitan Borough Council.

The objectives of the charity remain:

- To maintain the premises of Astley Burf as a school camp for the benefit of children and young persons of the Borough of Dudley;
- To administer the assets and liabilities of the camp and
- To permit Dudley Metropolitan Borough Council's Regeneration & Enterprise Directorate Management Team (DMT) to allow people to have full use and occupation of the premises for the purposes of a camp for children and young persons.

The Trustees have had regard to the guidance issued by the Charity Commission on public benefit.

Achievements and Performance

Due to the Covid19 pandemic the Astley Burf Outdoor Education Centre was closed for the period 1/4/20 – 31/3/21. As a result, the main income received was from the Council as a contribution to the costs of maintenance of grounds and property.

Significant items of expenditure during the financial year include staff pay and premises related costs such as heating and lighting.

In terms of school visits, no children attended the activity centre in the period as a result of the site's closure.

Financial Review

The Charity has received income in the financial year from lettings and sale of souvenirs £2,392. It has also received income from Council support of £132,208

.

This has met the costs in the financial year of £134,600 incurred on delivering the service to the children including maintenance of grounds and property.

The Charity does not hold reserves. If income received from lettings or other income relating to the premises is not sufficient to meet the costs of providing the service, the Council will make the required contribution to break even in the year.

The property is currently valued at £200,000. It was revalued in 2020.

The Charity currently has no investments.

Structure, Governance and Management

The charity was established in 1938 by Deed of Gift and is registered with the Charity Commissioners (No 1037595).

The Trustee of the Charity is Dudley Metropolitan Borough Council.
