Church Crookham County Junior School Association (Charity Number: 1037725) (PTA) was established 23 May 1994 for the purpose of making charitable grants to Church Crookham Junior School (CCJS). The Charity is registered in England and Wales and is governed by its constitution which was adopted on 7 March 1994 and amended on 15 June 2023.

The Charity aims to raise funds by running a variety of school events and activities with the help from school teachers and parents, and fund various school projects.

Public benefit

The Trustees have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Charities aims and objectives and in planning future activities. In particular the Trustees considered how planned activities will contribute to the aims of the Charity and the objectives they have set and have therefore complied with the duty in section 17 of the Charities Act 2011.

Taking into account the achievements and beneficiaries of the Charity as described below, the Trustees confirm that due regard had been paid to the public benefit guidance published by the Charity Commission.

Review of activities

This report covers financial year from 1st September 2024 to 31st August 2025.

The total income for the year 2025 was £ 40969 (FY 2024: £ 31541), an increase on previous year of 30%. This is due to increase in activities.

The total payments for the FY25 were £ 38174 which included funding to school of £ 23475K (FY24: total payments £ 34174, including a £ 23475 payment to CCJS). This £ 38174 covered the funding for the School Library Refit, Banners for the Fleet Carnival, educational visits from Reindeers, Alpacas, Zac – Gladiator Healthy Lifestyle, together with Fireworks and Paint Powders for Color Run that the PTA reimbursed the school for purchasing of items to sell at events.

The following events have taken place during the year 2025: second hand uniform sale, tea towels sale, disco, Christmas Card sale, Christmas Shop, Father's Day and Mother's Day shops, Summer Fair, Easter eggs raffle, Color Run and Fireworks.

PTA have funded the following events and items during the year: Fantastic Friday, Christmas Crackers, autograph books for year 6 children together with their leaving party with photo booth and educational visits from Zac from Gladiators, Alpacas and Reindeer visits to the school.

Reserves policy

The current formal reserves policies is that the Trustees intend to hold sufficient funds in reserve so as to ensure the charity can continue to meet its long-term objectives. The Trustees will finalise its full fundraising strategy with the aim of expanding its charitable activities in the future.

The financial statements have been prepared on a going concern basis which the Trustees consider to be appropriate for the following reasons.

There have been no material post balance sheet date events that would affect this assessment.

Consequently, the Trustees are confident that the charity will have sufficient funds to continue to meet its liabilities as they fall due for at least 12 months from the date of approval of the statements.



Review of activities

This report covers financial year from 1st September 2023 to 31st August 2024.

The total income for the year 2024 was £31.5K (FY 2023: £36K), a decrease on previous year of 14%. This is partly due to the current climate and families disposal income.

The total payments for the FY24 were £35K which included funding to school of £22K (FY23: total payments £41K, including a £18.5K payment to CCJS). This £22K covered the funding for replacing two sheds with containers, bike shed replacements, class room funding for book corners of £200 per class (20 classes), together with £100 per class for each class to spend as desired on Games, Lego, Toys for their own needs together with Fireworks and Paint Powders for Colour Run that the PTA reimbursed the school for purchasing.

The following events have taken place during the year 2024: second hand uniform sale, tea towels sale, disco, Christmas Card sale, Christmas Shop, Father's Day and Mother's day shops, Summer Fair, Easter eggs raffle, Colour Run and Fireworks.

PTA have funded the following events and items during the year: Fantastic Friday, Christmas Crackers, autograph books for year 6 children together with their leaving party with photo booth and the bike sheds and containers to replace rotten sheds.

The total income for the year 2023 was £36K (FY 2022: £47K), a decrease on previous year of 23%. This is partly due to the Grants received from Farnborough Airport £5K and £15K from the Parish Council in 2022. Excluding these grants the income from 2022 was £27K compared to £35K in 2023, which is a 34% increase.

The total payments for the FY23 were £57K which included funding to school of £33.5K (FY22: total payments £29K, including a £15K payment to CCJS). This £33.5 covered the grant money for the play equipment, together with an additional £14K of PTA funding for the play equipment, King Charles Coronation Coins that the PTA reimbursed the school for purchasing.

Objectives of the Charity

Church Crookham County Junior School Association (Charity Number: 1037725) (PTA) was established 23 May 1994 for the purpose of making charitable grants to Church Crookham Junior School (CCJS). The Charity is registered in England and Wales and is governed by its constitution which was adopted on 7 March 1994 and amended on 15 June 2023.

The Charity aims to raise funds by running a variety of school events and activities with the help from school teachers and parents, and fund various school projects.

Public benefit

The Trustees have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Charities aims and objectives and in planning future activities. In particular the Trustees considered how planned activities will contribute to the aims of the Charity and the objectives they have set and have therefore complied with the duty in section 17 of the Charities Act 2011.

Taking into account the achievements and beneficiaries of the Charity as described below, the Trustees confirm that due regard had been paid to the public benefit guidance published by the Charity Commission.

Review of activities

This report covers financial year from 1st September 2021 to 30th August 2022.

The total income for the year 2022 was £46.8k (FY 2021: £6.6k), an increase on previous year of 704%. This is partly due to the additional Grants received from Farnborough Airport £5k and £15k from the Parish Council. Excluding these grants the increase on the previous year was 403%, following the reduced activity during the previous year, as it was greatly affected by the pandemic.

The total expenses for the FY22 were £29.2k which included funding to school of £15.2k (FY21: total expenses £6.0k which included funding of £4.5k).

The following events have taken place during the year 2022: second hand uniform sale, tea towels sale, disco, PTA sale of a various surplus stock, Christmas cards sale, Father's day and Mother's day shops, summer fair, Easter eggs raffle and the fireworks.

PTA have funded the following events and items during the year: Fantastic Friday and sport's leaders t-shirts, Christmas crackers, autograph books for year 6 children and the play equipment.

Reserves policy and going concern

Whilst there's no current formal policy, the Trustees intend to hold sufficient funds in reserve so as to ensure the charity can continue to meet its long term objectives. The Trustees will finalise its full fundraising strategy with the aim of expanding its charitable activities in the future.

The financial statements have been prepared on a going concern basis which the Trustees consider to be appropriate for the following reasons.

The business model of the charity is such that its charitable activities are limited to those which it has sufficient

funds and investments held to support from the excess of income received over the costs of administering the charity. The charity therefore has no specific commitments and no committed costs beyond its fixed costs of operation.

The Trustees have reviewed the cash flow forecasts for a period of 12 months from the date of approval of these financial statements which indicate that the charity will have sufficient funds to meet its liabilities as they fall due for that period. The Trustees consider that even if no further external funding is received in the 12-month period, the charity has sufficient cash reserves and available investments to pay all committed costs. There have been no material post balance sheet date events that would affect this assessment.

Consequently, the Trustees are confident that the charity will have sufficient funds to continue to meet its liabilities as they fall due for at least 12 months from the date of approval of the statements.
