Report of the Trustees **for the Year Ended 31st January 2024**

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31st January 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

Safer Medicines Trust is established to :-

- a) undertake and advance research into the effectiveness and benefit to the general public of medical experiments on animals;
- b) provide information and to educate the public as to the results of such research;
- c) do any other charitable activity.

ACHIEVEMENT AND PERFORMANCE

Charitable activities and achievements

Our major activity and achievement this year was the completion, publication and marketing of our landmark popular science book: "Rat Trap: the capture of medicine by animal research - and how to break free." In Rat Trap, our Research Director, Dr Pandora Pound, comprehensively dismantles the case for animal research, bringing to an end the 150-year-old debate about its value once and for all. Rat Trap slays the many myths about animal research and shows that, far from being a necessary evil, it is one of the most important and urgent scientific issues of our time.

We began our publicity campaign with an online launch (270 participants) a month before the book's publication. We printed 40,000 leaflets and flyers, urging our supporters to buy and share the book, and sent the ebook to scientists, celebrities, campaigners, journalists, and patient safety advocates, using complimentary Google and Apple codes. Free print copies were sent to over 100 key individuals and ebooks were offered to every biology teacher in the UK. We invited local and independent bookshops to stock Rat Trap, as well as online sellers, including Amazon. In the first 6 months since publication, we have sold over 1,000 of the 2,000 copies we printed.

We sold copies at WC12 in Canada and at the Animal Free Research UK conference in Cambridge. Pandora gave presentations to the Oxford Centre for Animal Ethics, the Alliance for Human Relevant Science and the Humanimal Trust. She gave interviews for local BBC radio, Talk Radio Europe, German public radio, the US National Antivivisection Society, Redbrick Science and Technology, Psychology Today, Antidote Europe, What Doctors Don't Tell You (WDDTY), and for podcasts (with Animal Free Research UK, Animal Free Science Advocacy (Australia), PETA US, Pharmaphorum). She wrote articles for a range of publications, including the magazines Medicine Maker, Drug Discovery World and International Pharmaceutical Industry, and for charities (Patient Safety Learning, Independent Living). The book was referenced in a Daily Telegraph article and WDDTY published an abridged extract in their magazine.

Rat Trap received excellent reviews on Amazon, Goodreads and the website of our publisher, Troubador. Glowing reviews were published by Animal Aid, AFR-UK, PETA, Antidote Europe, Wellbeing International, the scientific journal Altex and the magazine Cygnus Review. It has been described as 'an unflinching exposé', 'almost like a thriller', 'meticulously researched', 'powerful', 'hard-hitting', 'compelling', a 'game-changer', 'essential reading for funders, policymakers, scientists and ethicists' and importantly, 'highly readable' and 'accessible to diverse readers from laypersons to senior researchers.' Many of our supporters sent copies to their MPs, and one donated her winter fuel payment, enabling us to offer free copies to libraries. Rat Trap was shortlisted for a 2024 Lush Prize for public awareness.

Other activities included co-hosting a conference at the Royal Society in April on drug-induced liver injury (DILI), as a partner of the Alliance for Human Relevant Science. Our Pharmaceutical Director, Dr Gerry Kenna, co-hosted the event, as he is an international expert on DILI. A paper on the topic for future publication is in progress.

FINANCIAL REVIEW

Reserves policy

The Trustees have resolved to establish reserves with a reputable UK bank for future funding activities of the charity, and the Trustees have powers of investment in such assets as they see fit.

Financial Review

During the year, the Charity raised £107,748 (2023: £26,588) as voluntary donations including generous legacy of £72,758 from Elizabeth Lewis-Cracknell.

These funds were used to promote the campaigns and educations through attendance at several conferences and events and overhead expenses.

As shown in the Statement of Financial Activities, the Charity still holds £86,678 (2023: £29,720) which will be used as the programmes progress.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The Charity is controlled by its governing document, a Memorandum and Articles of Association, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

The company is limited by guarantee and therefore has no share capital. Each Trustee's guaranteed liability is limited to £1.

It is the view of the Trustees and stated in the Memorandum and Articles of Association that the surplus of funds is not available for distribution to the Trustees but it is for the sole purpose of achieving the main objects of the charitable company.

Recruitment and appointment of new trustees

The management of the charity is the responsibility of the Trustees who are elected and co-opted under the terms of the Articles of Association.

The number of Trustees shall not be less than three but shall not be subject to any maximum. At every Annual General Meeting (AGM), one-third of the Trustees who are subject to retirement by rotation or, if their number is not three or a multiple of three, the number nearest to one-third shall retire from office, but, if there is only one Trustee who is subject to retirement by rotation, he or she shall retire. Additional Trustees can be appointed by recommendation of the existing Trustees or by standing for election at the AGM.

Induction and training of new trustees

All new Trustees, once elected, are inducted by the Chair Trustee, Ms K Archibald. All new Trustees are handed the charity's organisational policies and documents. All Trustees are encouraged to attend regular training courses made available through the NCVO, LVSC and other local voluntary support bodies such as HAVS, as well as utilising online resources for Trustees and attend networking opportunities.

Statement on Public Benefit

The Trustees have referred to the guidance issued by the Charity Commission's general guidance on public benefit when reviewing the Trust's aims and objectives and in planning its future activities.

In particular, we have considered how planned activities will contribute to the aims and objectives set.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Computer equipment - 25% on cost

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

Vat

The charity is not registered for VAT (Value Added Tax). In common with many other similar charities, the expenses are inflated by VAT, which cannot be recovered.

ACHIEVEMENT AND PERFORMANCE

Charitable activities and achievements

In March, along with our partners in the Alliance for Human Relevant Science, we helped launch an important report in Parliament by the The All Party Parliamentary Group for Human Relevant Science. In the report: "Bringing back the human: transitioning from animal research to human relevant science in the UK", MPs from the APPG call for a transition to human relevant science to advance medical progress.

In October, again with our Alliance partners, we hosted an exceptional event at the Royal Society of Medicine, entitled "Cancer research - a new paradigm." Chaired by our Patron, Dr James Le Fanu, Professors Azra Raza and Geoff Pilkington gave inspirational talks, followed by riveting discussions with the expert audience.

Our Pharmaceutical Director, Dr Gerry Kenna, presented a virtual seminar on "In vitro models for assessment of drug-induced liver injury (DILI)" to the Liver Toxicity Working Group of the US regulator, the FDA.

Our Scientific Consultant, Rebecca Ram, co-authored a paper on "The role of 'big data' and 'in silico' New Approach Methodologies (NAMs) in ending animal use - a commentary on progress".

Our Research Consultant, Pandora Pound, co-authored a scientific appraisal of animal research over the past 20 years: "The role of systematic reviews in identifying the limitations of preclinical animal research, 2000 - 2022."

Our Director, Jan Turner, co-authored an analysis of the origins of animal safety test requirements and whether they were justified then or now: "A History of Regulatory Animal Testing: What Can We Learn?"

In collaboration with Alliance partners, we led a series of 5 workshops with 13 international experts to identify feasible NAMs and discuss how to use them in specific contexts. The culmination of this work was a published report: "Incorporating new approach methodologies into regulatory nonclinical pharmaceutical safety assessment." We hope others will build on this work and use it to speed the transition to greater human relevance, which is so urgently needed.

After all this work, our Director, Dr Jan Turner, very sadly left to take up a new role with Axol Bioscience but happily, remains one of our Science Advisers. She recorded an excellent podcast about organ-on-chip technology before she left.

Safer Medicines Trust was a partner in a world-first comparative study led by the US Evidence-based Toxicology Collaboration (EBTC) and the Norwegian Institute of Public Health, which was published in Nature Scientific Reports in March 2021. This landmark study demonstrates that human-relevant technologies offer a new paradigm for preventing adverse drug reactions and saving patients' lives. Such new approach methods can outperform animal tests and even human clinical trials in detecting a new medicine's subtle signals of harm. We are very proud to have helped to bring this important study, which we have been advocating for many years, into the scientific consciousness.

Our Director, Dr Jan Turner, was again invited to speak on "The future of medicines regulation in the UK" at a virtual Westminster Health Forum meeting in April. Her talk described why innovation to ensure safe and effective medicines is imperative for the UK. She emphasised that we are calling for a regulatory system fit for the 21st century, which uses human-relevant science to deliver safer and more effective medicines more quickly and at less cost. Jan also gave a webinar at a symposium of the EBTC on overcoming data availability obstacles, highlighting the crucial need for ALL data, both negative and positive, clinical and preclinical, to be published. Without full transparency of data, to reduce bias, improper influence and misrepresentation, there can be no public trust in decisions taken regarding approval of medicines or other public health interventions.

Our Scientific Consultant, Rebecca Ram, and our Research Consultant, Pandora Pound, both gave talks at the 11th World Congress on Alternatives and Animal Use in the Life Sciences in August and September 2021, on "New Approach Methodologies Funding and Regulation", and "Breaking the lock-in to animal research within academia", respectively. Rebecca also gave a presentation on advancing human relevant research via New Approach Methodologies in November 2021, and Pandora gave a lecture for the course: Animals in Research: Law, Policy, and Humane Sciences, at Johns Hopkins Bloomberg School of Public Health, USA. All presentations are available on our website.

We were shocked and devastated by the murder of our wonderful Patron, Sir David Amess, who supported our work so enthusiastically for many years, saying: "I am passionate about both human health and animal welfare, and I applaud Safer Medicines Trust for showing that there is no contradiction between the two, as we are so often led to believe." We are honoured and grateful to have had his invaluable support and we miss him terribly.

Report of the Trustees
for the Year Ended 31st January 2021

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31st January 2021. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

Safer Medicines Trust is established to :-

- a) undertake and advance research into the effectiveness and benefit to the general public of medical experiments on animals;
- b) provide information and to educate the public as to the results of such research;
- c) do any other charitable activity.

ACHIEVEMENT AND PERFORMANCE

Charitable activities and achievements

In March, alongside several of our Alliance for Human Relevant Science partners, we launched our joint white paper: "Accelerating the Growth of Human Relevant Sciences in the United Kingdom" in Parliament. Several MPs attended and signed Early Day Motion (EDM) 256: "Accelerating human relevant life sciences in the UK", which was launched by Sir David Amess MP on the same day. 103 MPs signed this EDM, making it the 8th most popular out of 2,276 EDMs in the 2019-2021 parliamentary session, showing just how important the issue is to MPs and their constituents. We sent a Briefing Document summarising the White Paper and its recommendations to every MP.

We worked with our Alliance partners and Grahame Morris MP to establish a new All-Party Parliamentary Group for Human Relevant Science. Grahame, as Chair, hosted its virtual launch in October and its first meeting in November, with excellent talks from some eminent speakers. He also asked Parliamentary Questions and helped us engage with ministers. Please see www.HumanRelevantScience.org for more details.

We joined with nearly 100 other scientists and organisations in signing an Open Letter to the World Health Organisation, national governments, funding bodies and regulators calling for human relevant methods to be prioritised to help the discovery of effective vaccines and treatments for Covid-19. We also co-authored an Open Letter to 10 regulatory bodies, which cited the Alliance White Paper and was published in the Guardian on 14th July.

Our Pharmaceutical Director, Dr Gerry Kenna, spoke at the Physicians Committee for Responsible Medicine (PCRM) US Congressional hearing "Confronting Covid-19: A Briefing on Prioritizing Human-Based Research". A recording of the event and Dr Kenna's slides are on our website, as are the letters above.

Our Director, Dr Jan Turner helped as an expert reviewer to award the "Fast-track grant for research on non-animal approaches to investigate mechanisms, medicines, and vaccines for coronaviruses" from the Johns Hopkins Center for Alternatives to Animal Testing, USA.

Dr Turner gave virtual presentations at the Advances in Cell and Tissue Culture conference, the American Society for Cellular and Computational Toxicology Annual Meeting, and a Westminster Health Forum meeting on Developing Methods and Technologies to Ensure Safe and Effective Medicines.

We had three scientific publications during the year, links to all of which are available via our website:

- 1) A paper in BMJ Open Science by Dr Pandora Pound and Rebecca Ram, entitled: "Are researchers moving away from animal models as a result of poor clinical translation in the field of stroke? An analysis of opinion papers."
- 2) A chapter by Dr Pound: "Animal models and the search for drug treatments for traumatic brain injury" in the book: Neuroethics and nonhuman animals, Johnson L, Fenton A, Shriver A (Eds). 2020, Springer, Switzerland.
- 3) Dr Pandora Pound guest edited a special issue of the journal 'Animals' entitled "Are Animal Models Needed to Discover, Develop and Test Pharmaceutical Drugs for Humans in the 21st Century?"

FINANCIAL REVIEW

Reserves policy

The Trustees have resolved to establish reserves with a reputable UK bank for future funding activities of the charity, and the Trustees have powers of investment in such assets as they see fit.

Financial Review

During the year, the Charity raised £25,718 (2020: £10,185) as voluntary donations.

These funds were used to promote the campaigns and educations through attendance at several conferences and events and overhead expenses.

As shown in the Statement of Financial Activities, the Charity still holds £42,207 (2020: £130,366) which will be used as the programmes progress.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The Charity is controlled by its governing document, a Memorandum and Articles of Association, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

The company is limited by guarantee and therefore has no share capital. Each Trustee's guaranteed liability is limited to £1.

It is the view of the Trustees and stated in the Memorandum and Articles of Association that the surplus of funds is not available for distribution to the Trustees but it is for the sole purpose of achieving the main objects of the charitable company.

Recruitment and appointment of new trustees

The management of the charity is the responsibility of the Trustees who are elected and co-opted under the terms of the Articles of Association.

The number of Trustees shall not be less than three but shall not be subject to any maximum. At every Annual General Meeting (AGM), one-third of the Trustees who are subject to retirement by rotation or, if their number is not three or a multiple of three, the number nearest to one-third shall retire from office, but, if there is only one Trustee who is subject to retirement by rotation, he or she shall retire. Additional Trustees can be appointed by recommendation of the existing Trustees or by standing for election at the AGM.

Induction and training of new trustees

All new Trustees, once elected, are inducted by the Chair Trustee, Ms K Archibald. All new Trustees are handed the charity's organisational policies and documents. All Trustees are encouraged to attend regular training courses made available through the NCVO, LVSC and other local voluntary support bodies such as HAVS, as well as utilising online resources for Trustees and attend networking opportunities.

Statement on Public Benefit

The Trustees have referred to the guidance issued by the Charity Commission's general guidance on public benefit when reviewing the Trust's aims and objectives and in planning its future activities.

In particular, we have considered how planned activities will contribute to the aims and objectives set.

This report has been prepared in accordance with the special provisions of Part 15 of the Companies Act 2006 relating to small companies.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Computer equipment - 25% on cost

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

Vat

The charity is not registered for VAT (Value Added Tax). In common with many other similar charities, the expenses are inflated by VAT, which cannot be recovered.
