

The financial statements have been prepared under the historical cost convention and in accordance with the Statements of Recommended Practice, Accounting and Reporting by Charities (SORP 2015), applicable accounting standards FRS102 and the Companies Act 2006. The principal accounting policies adopted in the preparation of the financial statements are as follows :

Cash Flow

The financial statements do not include a cash flow statement for the Company, as a Small Reporting Entity, is exempt from the requirement to do so under FRS 102.

Donations and Grants

Income from donations and grants, including capital grants, is included in incoming resources when these are receivable, except as follows :




