Objects: (1) TO RELIEVE POVERTY OF PERSONS OF ETHIOPIAN ORIGIN BY THE PROVISION OF ADVICE AND IN SUCH OTHER WAYS AS THE COMMITTEE DETERMINE; (2) TO ADVANCE THE EDUCATION OF THE PUBLIC BY THE PROVISION OF CLASSES IN COMPUTING ENGLISH AND ETHIOPIAN LANGUAGES; (3) TO ADVANCE PUBLIC HEALTH BY THE PROVISION OF COUNSELLING TO PERSONS SUFFERING FROM DEPRESSION AND POST-TRAUMATIC SHOCK SYNDROME AND BY THE RELIEF OF THE DISABLED; (4) TO PROVIDE FACILITIES IN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION OR OTHER LEISURE TIME OCCUPATION WITH THE OBJECT OF IMPROVING THE CONDITIONS OF LIFE OF THE PUBLIC

The charity is established to relieve hardship, address causes of poverty and advance the education of the public, especially of those in disadvantaged, by providing information advice guidance and support, providing basic skills and learning opportunities.
