**Income:** Income for the year increased to £59,422.37 due in large part to the very generous legacy from the Estate of Mrs Pamela Janes.

**Expenditure:** During the year was up from £3,152.61 to £7985.33:

£5,000.00 Towards boiler-room asbestos removal  
£1,348.00 Peter camp memorial bench  
£1,385.00 Tower door replacement  
£189.00 Annual Insurance  
£63.32 AGM catering

In view of the significant costs associated with repairs to the damaged plaster above the chancel steps the Mrs Janes' legacy could not have been timelier and will enable scaffolding to be erected to determine the cause and extent of the problem. Until these questions are answered it is not possible to predict what the final cost will be.

Looking to the future, it is highly likely that we will need to undertake some additional fundraising through increasing membership, annual donations and encouraging legacies.
