The Trustees present their annual report and financial statements of the charity for the year ended 30th June 2022. The financial statements have been prepared in accordance with the charity's trust deed, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) update bulletin 2 (effective 1st January 2019).

OBJECTIVES AND ACTIVITIES FOR THE PUBLIC BENEFIT

The objects of the Trust are to promote such charitable purposes for the benefit of young people living in Leicestershire and Rutland, in particular, those undertaken by youth organisations, as the trustees in their absolute discretion think fit.

Grant making policy

Modest grants are made to individual young people and the Trust also makes grants to voluntary youth organisations with which Sir Andrew Martin was closely involved. All grants are made at the discretion of the Trustees to support the aspirations and needs of young people and their voluntary organisations.

Public benefit

In planning the Trust's grant making the trustees have given consideration to the Charity Commission's published guidance on public benefit.

ACHIEVEMENTS AND PERFORMANCE

The Trust has made £27,976 (2021: £14,820) in grants to improve the lives of young people who live in Leicester, Leicestershire or Rutland. The Trust has actively supported the aspirations and needs of young people who have an outstanding skill or talent, the opportunity to gain a unique experience, or who are disadvantaged, have disabilities, learning difficulties, special educational needs or mental health issues. The Trust has also supported voluntary youth organisations which are making a significant contribution to benefit young people and the wider community.

Investments have been managed throughout the year by the Investment Managers, with performance being monitored by the Trustees of Liverpool Charity and Voluntary Services through its Investment Committee meetings.

FINANCIAL REVIEW

Income from investments of £34,812 (2021: £32,360) and donations totalling £14,369 (2021: £14,056) was received during the year. Grants of £27,976 (2021: £14,820) were made. At the year end capital investments were valued at £1,284,696 (2021: £1,405,328).

Investment policy and powers

The trustees have the same full and unrestricted powers of investment in all respects as if they were the beneficial owners.

The investment strategy is set by the trustees and takes account of recent demands for funds and an assessment of expected future needs (see Reserves). The investment policy and strategy are

reviewed with the investment managers at regular intervals.

The investment objective is to maximise income available to make grants while maintaining the long-term value of capital.

Risk management

The main risks to which the charity is exposed as identified by the trustees have been considered and systems have been established to mitigate those risks.

Reserves

The Trust Deed permits the spending of capital; the trustees have, however, agreed to retain the capital for the time being and to invest it to produce income to make grants. The trustees are managing the reserves to balance the needs of current and future beneficiaries. It is not anticipated that the needs of beneficiaries will diminish over time.

Plans for the future

The objectives of the Trust remain unchanged for the future; the intention is to continue managing the funds on a consistent basis and distributing income as grants to those in financial need.

Covid Times continued through 2021 -2022

Although the trustees resumed meetings in person instead of online, the proposed 25th Anniversary event at Leicester's Curve theatre was, again, postponed due to Covid risks. Late in 2021, the event was re-styled "Celebration" to focus attention on the Trust's award of £500,000 in grants since 1994 and planning resumed to hold the event on Tuesday 27 September 2022.

The trustees continued their advertising of grant availability to young people and their voluntary organisations, not least by an hour's online (by Zoom) event in November 2021. About a dozen groups attended and received information from three trustees, whilst two grant holders reported on activities for which they had received grants.

The Trust's most efficient Honorary Treasurer since 28 April 2009, Alec Jeffery, gave a year's notice to retire in January 2023. Arrangements are in hand to appoint his successor.

At their meeting on 27 January 2022, the trustees welcomed and appointed Samuel Plummer to the Board of Trustees. Sam had previously been instrumental in designing and building the Trust's attractive new website and brings to us his skills relating to technology and music, as well as being considerably younger than several of the trustees!

On the 20 June 2022, Terence Higgins OBE DL retired as a trustee having served, continuously, since 1994 on the original planning meetings from which the Trust was created and then on the trustee board. He will be greatly missed for his always carefully considered approach to grant applications, matters generally and wise advice. Even at 95 he is reluctant to give in.

Also, a sad retirement at the end of March 2022 was that of Ken Martin of LCVS from his liaison role with us representing our Corporate Trustee body of LCVS trustees. We first welcomed Ken to our trustees' meeting on the 29 April 2003 since then he has been a most reliable guide on charity matters and a welcome attendee at our September meeting.

The trustees look forward with hope that their publicity events in these last two years will turn the tide of applications at our quarterly grant meetings. Before Covid times it was not unusual to have even thirty individual and group applications to consider at each meeting. The trustees are keen to see the trust fund supporting active youth groups and individual young people throughout every year; indeed, providing young people with a brighter future.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The Sir Andrew Martin Trust for Young People is a registered charity, number 1042358. It was established by a Trust Deed dated 18th November 1994.

Organisation, management and delegation

The administration of the Trust's grant making activities is carried out, at no cost to the Trust, by a volunteer from Samworth Brothers.

The Trustees meet quarterly to make grants and review the Trust's performance, its financial position and its investments. The Trustees, in their power, have delegated accountancy matters to LCVS.

Trustee recruitment and appointment

Having considered relevant skills, experience, and geographical requirements, potential new Trustees are approached by the existing Trustees and then appointed with the agreement of the Trustees. The Trustees are also responsible for the induction and training of new Trustees.

Independent Examiner's Report to the Trustees of

I report to the trustees on my examination of the accounts of The Sir Andrew Martin Trust for Young People ('the charity') for the year ended 30th June 2022, which are set out on pages 8 to 15.

Responsibilities and basis of report

As the trustees of the charity you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the 2011 Act').

I report in respect of my examination of the charity's accounts carried out under section 145 of the 2011 Act and in carrying out my examination I have followed all the applicable Directions given by the Charity Commission under section 145 (5)(b) of the 2011 Act.

An independent examination does not involve gathering all the evidence that would be required in an audit and consequently does not cover all the matters that an auditor considers in giving their opinion on the accounts. The planning and conduct of an audit goes beyond the limited assurance that an independent examination can provide. Consequently, I express no opinion as to whether the accounts present a 'true and fair view' and my report is limited to those specific matters set out in the independent examiner's statement.

Independent examiner's statement



1. ACCOUNTING POLICIES

Basis of preparation

The accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) and Charities Act 2011.

The trust constitutes a public benefit entity as defined by FRS 102.

The accounts are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest £.

The Charity has taken advantage of the provisions in the SORP for Charities applying FRS 102 Update Bulletin 1 not to prepare a Statement of Cash Flows.

Going concern

At the time of approving the accounts the trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus the trustees continue to adopt the going concern basis of accounting in preparing the accounts.

Fund accounting

Unrestricted funds are considered 'free' reserves and are expendable at the discretion of the Trustees in furtherance of the general objectives of the Trust.

Investments

Investments held as fixed assets, in accordance with SORP 2019 are stated and included in the balance sheet at their market value at the valuation date nearest to the year end. Realised and unrealised gains and losses are dealt with as movements on the Capital Fund. Investments are valued at the mid-market price on the valuation date.

The main form of financial risk faced by the charity is that of volatility in equity markets and investment markets due to wider economic conditions. The Trustees conduct a thorough risk analysis in conjunction with their investment managers at each of their Investment Committee meetings.

Income recognition

Income from investments comprises dividend income and interest and are accounted for when received in the financial year.

Donations are recognised at the earlier of notification or date of receipt, in the case of the third party donations and legacy income when received by the organisation.

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that settlement will be required and the amount of the obligation can be measured reliably.

Expenditure recognition

All expenditure is accounted for on an accruals basis. All expenses, including support costs and

governance costs, are allocated or apportioned to the applicable expenditure headings in the statement of financial activities.

Raising funds costs relate to expenses incurred in the administration of the investment assets. Charitable activities includes grant funding, along with associated support costs, to beneficiaries. These are dealt with in the Statement of Financial Activities when payment has been approved by the charity. Governance costs relate to compliance with constitutional and statutory requirements and specifically include all costs incurred by the charity in producing the Annual Report.

Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks, other short-term liquid investments with original maturities of three months or less, and bank overdrafts.

Financial instruments

The charity has elected to apply the provisions of Section 11 'Basic Financial Instruments' and Section 12 'Other Financial Instruments Issues' of FRS 102 to all of its financial instruments.

Financial instruments are recognised in the charity's balance sheet when the charity becomes party to the contractual provisions of the instrument.

Financial assets and liabilities are offset, with the net amounts presented in the financial statements, when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

Basic financial assets

Basic financial assets, which include debtors and cash and bank balances, are initially measured at transaction price including transaction costs and are subsequently carried at amortised cost using the effective interest method unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest. Financial assets classified as receivable within one year are not amortised.

Basic financial liabilities

Basic financial liabilities, including creditors and bank loans are initially recognised at transaction price unless the arrangement constitutes a financing transaction, where the debt instrument is measured at the present value of the future receipts discounted at a market rate of interest. Financial liabilities classified as payable within one year are not amortised.

Debt instruments are subsequently carried at amortised cost, using the effective interest rate method.

Derecognition of financial liabilities

Financial liabilities are derecognised when the charity's contractual obligations expire or are discharged or cancelled.

Taxation

The charity benefits from various exemptions from taxation afforded by tax legislation and is not liable to corporation tax on income or gains falling within those exemptions. The charity is not able to recover Value Added Tax. Expenditure is recorded in the accounts inclusive of VAT.

2. CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

In the application of the charity's accounting policies, the trustees are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.
