Objects: PROMOTING THE EDUCATION [INCLUDING SOCIAL AND PHYSICAL TRAINING] OF PERSONS UNDER THE AGE OF 25 YEARS WHO OR WHOSE PARENTS ARE RESIDENT IN THE PARISHES OF CHURCHILL AND SARSDEN AND WHO ARE IN NEED OF FINANCIAL ASSISTANCE AND IN PARTICULAR BUT WITHOUT PREJUDICE TO THE GENERALITY OF THE FOREGOING A] IN AWARDING TO SUCH PERSONS SCHOLARSHIPS, EXHIBITIONS, BURSARIES, MAINTENANCE ALLOWANCES OR GRANTS TENABLE AT ANY SCHOOL, UNIVERSITY, COLLEGE OF EDUCATION, OR OTHER INSTITUTION OF FURTHER [INCLUDING PROFESSIONAL AND TECHNICAL] EDUCATION APPROVED FOR THE PURPOSE BY THE TRUSTEES; B] IN PROVIDING FINANCIAL ASSISTANCE, OUTFITS, CLOTHING, TOOLS, INSTRUMENTS OR BOOKS TO ASSIST SUCH PERSONS TO PURSUE THEIR EDUCATION [INCLUDING THE STUDY OF MUSIC AND OTHER ARTS], TO UNDERTAKE TRAVEL IN FURTHERANCE THEREOF, OR TO PREPARE FOR OR ENTER A PROFESSION, TRADE, OCCUPATION OR SERVICE ON LEAVING SCHOOL, UNIVERSITY, OR OTHER EDUCATIONAL ESTABLISHMENT.

Activities: Promote education of persons under 25 who are resident in the Parishes of Churchill and Sarsden. Award maintenance allowances at any school, university, college or institution of further education (including professional and technical) approved by the Trustees. Provide financial assistance towards outfits, clothing, tools, instruments, books or travel connected with their study.
