Activities

In order to achieve its charitable objectives the association holds an annual scientific meeting which provides a platform for education and the exchange of ideas relating headache, specifically the relief of sickness and protection of health in connection therewith. This meeting, together with other activities undertaken from time-to-time, enables the association to meet the Charity Commission's public benefit criteria.

Review of the achievements in the year ended 31st December 2024

The 34th Anglo Dutch Migraine Association meeting was held in Ghent Belgium on 15th June 2024. The meeting was organised by Dr Koen Paelmeliere. The meeting was well attended with full lecture theatre and lively discussions. The Chairman introduced the new members of ADMA named as Dr Sophie Dorsey (UK), Dr Michell Oswal (UK), Dr Mieke Heitkamp (NL), Dr Suzanne Geerts (NL), Dr Iris Meeuwis (NL) and Dr Stas Zylics (NL). The programme in 2024 included topics of general interest including other comorbidities of migraine such as epilepsy, autoimmune and psychiatric disorders. The Marcia Wilkinson Memorial Lecture was delivered by Anna Andreou from King's College, London and invited lectures were given by Dr Emile Couturier and Professor Jan Versijpt.

Results and financial position

The receipts and payments account for the year ended 31st December 2024 is set out on page 6. The receipts for the year were £ 26343 and the expenses were £ 42885 with the total deficit of £ 16542 in the year 2022. The bank balances totalled £ 54662 at December 2021 were £ 57827 on December 31st 2024. The overall deficit was a result of lack of sponsorship from the pharmaceutical industry and reserves were used to finance the annual meeting.

The trustees are of the opinion that the overall state of affairs of the association at 31st December 2024 is satisfactory and the association has a level of reserves which will effectively meet its future obligations.




