Shiva Charity aim to provide child centred, creative education for students in Nepal and Sri Lanka by improving their school environment with new buildings, paying teacher's salaries, repainting schools , providing clean drinking water, building new toilets, teacher training, providing school resources (such as computers/musical instruments,) and individual child school sponsorship.

Fundraising has been made possible by a variety of methods using our web-site, Facebook page and through our annual cultural visit to Nepal by friends of Shiva Charity. We have had regular loyal support from other charities such as the Wrington Vale Rotary Club and the R.A.O.B. In addition, we have a Just Giving page to make donations easier.

**Summary of the main achievements of the charity during the year**

In Sri Lanka in 2022, we provided monthly funding to pay the teachers at the Pitipana Pre School near Negombo.

Shiva Charity continued to provide monthly financial support to pay the teacher's salaries at Harold Whiting School near Banepa in Nepal.

**Jan** - Child sponsorship was provided for the poorer children at Dipshikha school, Nepal.

A new toilet block was completed at Harold Whiting School and an osmotic water filter was installed providing clean drinking water and a hand washing station with 4 taps.

**Feb** - Computer classes were provided at Dipshikha School with an annual subscription to the internet.

**March** - Thanks to the support of the Brit Valley Rotary Club an osmotic water filter was installed at Jyamdi School providing clean drinking water. Music classes took place at Harold Whiting School.

**April** - Shiva Charity paid the annual salary of 18 teachers in several poor school in the Midnapur region of India thanks to donations from friends of Maggie Flanagan.

12 students from Westonbirt school visited the Ginette Harrison School for three days delivering lessons to the children and helping paint the classrooms. Westonbirt school also raised funds to paint the whole of the outside of the Ginette Harrison School.

**May** - Shiva began to pay the salaries of teachers at Dipshikha School. Carpeting and cushions were provided at Jyamdi school.

**June/July** - Free teacher training was provided at the TVF centre in Banepa on a Saturday morning.

**August** - A new osmotic water filter was installed at Santa School to provide clean drinking water.

**September** - New musical instruments were bought for Sanga school including ukuleles

**October - December** Free computer classes were provided at the TVF centre in Banepa on a Saturday morning.

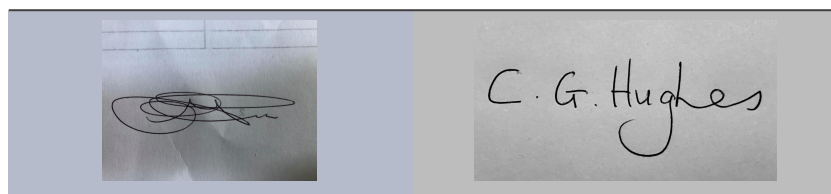



**Summary of the main achievements of the charity during the year**

In Sri Lanka we provided monthly funding to pay the teachers at the Pitipana Pre School near Negombo.

In Nepal, work continued on the building of 5 new classrooms at Dipshikha School thanks to the generous support of the R.A.O.B (Royal Antediluvian Order of Buffaloes) The school had been completely destroyed by the earthquake in 2015.

Shiva Charity continued to provide monthly financial support to pay the teacher's salaries at Harold Whiting School near Banepa.

Eight children were sponsored through their education in 2021. Tuition fees, exam fees, uniforms and books were paid for.

**Jan - March** - Concrete floors were laid in Dipshikha school and windows and doors fitted. Electricity was installed, false ceilings and new desks were provided for the classrooms.

**April** - Shiva Charity took over the administration of the Midnapur Project supporting 18 teachers in poor schools in India.

**May** - Schools reopened after a period of lockdown.

**June** - Toilets and washing facilities were completed at Dipshikha School.

**July - August** - Classrooms were painted at Dipshikha School

**September** - A new osmotic water filter was installed at Dipshikha School to provide clean drinking water.

Four new computers were installed and one year internet subscription provided.

**October - December** - Music lessons were restarted at Sanga School, Ginette Harrison School and Dipshikha School.

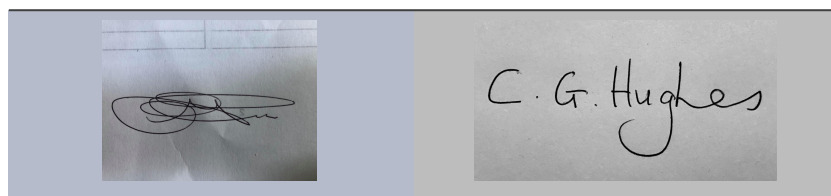
