This Charity, commonly known as FOSTA is registered with the Charity Commission No.1046026 and constituted by Deed of Trust dated 7th December 1994 as amended from time to time.

The Charity is administered by the Trustees and the Treasurer Mr Chris Imms.

The object of the Charity is to assist with the raising of funds for the maintenance, restoration and conservation of the fabric of St. Augustine's Church, the Grade 1 listed Parish Church of Broxbourne, Hertfordshire.

Funds are raised through membership, donations and events. During the period under review £28,222.13 was raised for future expenditure.

Membership fees, payable annually in May are currently £10 for single members and £15 for couples. Life membership is also available at a minimum cost of £100 for single members and £150 for couples.

The Annual General Meeting was held in the Church on 15th September 2024 after the FOSTA annual service.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF
THE FRIENDS OF ST AUGUSTINE'S BROXBOURNE Charity No 1046026

I report on the accounts of the trust for the year ended 30 April 2025 which are set out on pages 2 and 3.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 (the Charities Act) and that an independent examination is needed.
