The trustees of the Friends of Christ Church Wellington Heath submit their report and financial statements for the year ended 31 March 2023.

The charity is constituted under a trust deed dated 16 January 1995 and is a registered charity number 1046913.

The objects of the charity are as set out in its trust deed:

- a) the advancement of religion;
- b) to maintain, repair, restore, preserve, improve, beautify and reconstruct for the benefit of the public the fabric of the Church of Wellington Heath its monuments, fixtures, fittings, furniture, stained glass, ornaments and other chattels and its churchyard.

The management of the charity is undertaken by its trustees, not exceeding six in number (three of whom retire each year), together with the Rector, or his/her nominee, and a representative of the Parochial Church Council.

In order to carry out the charity's objects for the public benefit it supports the Parochial Church Council in the pursuit of its objects. Financial assistance has continued to be made available to the Parochial Church Council, to help meet the costs of running and maintaining the church. £536 was spent on the provision of a notice board in the church cemetery.

There was an increase in funds during the year ended 31 March 2023 from £8,269 to £35,139. The increase principally reflects the receipt of a donation from a resident of Wellington Heath of £25,000. This sum will be augmented in the current financial year by the recovery of Gift Aid on the donation. The charity is now in a position to make substantial grants to the Parochial Church Council towards the costs of major expenditure on the church building currently being undertaken. The trustees consider reserves to be sufficient to meet present commitments. Surplus funds are placed with the Central Board of Finance of the Church of England in investment and deposit accounts.

There are no major risks to which trustees consider the charity is exposed.

INDEPENDENT EXAMINER'S REPORT TO THE FRIENDS OF CHRIST CHURCH WELLINGTON HEATH

I report on the accounts of The Friends of Christ Church Wellington Heath for the year ended 31st March 2023 which are attached.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year (under Section 144 of the Charities Act 2011 (the 2011 Act)) and that an independent examination is required.

It is my responsibility to:

- examine the accounts under Section 145 of the 2011 Act
- to follow the procedures laid down in the General Directions given by the Charity Commission (under Section 145(5)(b) of the 2011 Act); and
- to state whether particular matters have come to my attention.

Basis of the independent examiner's report

My examination was carried out in accordance with the General Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a 'true and fair view' and the report is limited to those matters set out in the statements below.

Independent examiner's statement
