Objects: 1) FOR THE RESTORATION PRESERVATION REPAIR MAINTENANCE AND IMPROVEMENT OF THE PARISH CHURCH OF ALL SAINTS THURLESTONE ("THE CHURCH") IN THE DIOCESE OF EXETER AND THE COUNTY OF DEVON AND OF THE MONUMENTS, FITTINGS, STAINED GLASS, FURNITURE, ORNAMENTS AND CHATTELS IN THE CHURCH AND OF THE CHURCHYARD BELONGING TO THE CHURCH. 2) FOR THE BENEFIT OF THE PEOPLE OF THE SAID COUNTY OF DEVON AND THE SAID DIOCESE TO PRESERVE, REPAIR, MAINTAIN, IMPROVE AND RECONSTRUCT THE CHURCH AS A BUILDING OF HISTORICAL IMPORTANCE OR ARCHITECTURAL VALUE IN THE EVENT OF THE CHURCH BEING DECLARED REDUNDANT BY A PASTORAL SCHEME MADE UNDER THE PASTORAL MEASURE 1983 (OR ANY STATUTORY MODIFICATION OR RE-ENACTMENT THEREOF) OR OTHERWISE CEASING TO BE USED REGULARLY FOR PUBLIC WORSHIP AND THE MONUMENTS, FITTINGS, FIXTURES, STAINED GLASS, FURNITURE, ORNAMENTS AND CHATTELS IN THE CHURCH AND THE CHURCHYARD BELONGING THERETO
