**Objects:** 1) TO ADVANCE AND ENCOURAGE THE PRESERVATION OF THE COPTIC CHRISTIAN FAITH. 2) TO RELIEVE NEED, HARDSHIP AND DISTRESS OF PERSONS OF THE COPTIC CHRISTIAN FAITH WHO ARE OF SUDANESE NATIONALITY ORIGIN OR DESCENT AND WHO LIVE IN THE UNITED KINGDOM IN SUDAN OR ELSEWHERE; AND 3) TO WORK TOWARDS THE ELIMINATION OF RACIAL DISCRIMINATION AND PROMOTE EQUALITY OF OPPORTUNITY AND GOOD RELATIONS BETWEEN PERSONS OF DIFFERENT RACIAL GROUPS PARTICULARLY FOR THE BENEFIT OF PEOPLE WHO ARE OF SUDANESE NATIONALITY ORIGIN OR DESCENT AND WHO LIVE IN THE UNITED KINGDOM.

**Activities:** We provide advice and advocacy for Sudanese Coptic people to enable them to access services such as health, education, benefits and employment. We hold fortnightly family gatherings with sport, entertainments and lectures at Impulse Leisure centre, Southwick. We also arrange seasonal activities such as trips, parties and open days.
