TRUSTEES REPORT

The Trustees have pleasure in submitting their report, and accounts for the year ended 31st December 2020. The financial statements have been prepared in accordance with the accounting policies set out on page 5, and comply with the Statement of Recommended Practice and applicable law.

Constitution, objective of the charity, principal activities and organisation of our work

The charity is constituted under a trust deed dated 10th July 1995 and is a registered charity number 1048537.

The objectives of the charity as set out in the Declaration of Trust are:

- (a) The advancement of the Christian faith and
- (b) The relief of persons who are in conditions of hardship or distress or who are aged or sick.
- (c) Such other exclusively charitable purposes as the trustees may see fit.

The church was involved in Christian outreach programmes designed to increase Christian awareness and spread the Gospel of our Lord Jesus Christ.

Development, activities and achievements in the year

Before the pandemic we held our services and conferences with great levels of attendance. However, the covid-19 pandemic forced us to adapt to reaching our members virtually, and we have successfully organised all our annual conferences which included: Financial Matters; Family; Destined Women; Integrity Men; Youth; Children and Praise Week. The family and single parents conference continue to bring tremendous impactation in the life of attendees. Also the youth conference and the praise week saw once again, many youth being saved as they gave their lives to Jesus Christ. Our House Fellowship Ministry was moved online and is expected to return to various centres when government guidelines permit

The Destined Women's conference continue to inspire and reach out to women of all calibres. The conference was held virtually and women joined from all over the world. The conference gave women vision, new careers, entrepreneurs and many more

Also the Daily Devotional (Seed of Wisdom) continued to be distributed to members, adhering to all government guidelines, to help them grow in their faith in Christ Jesus.

Review of the financial position

Although our services and conferences were successfully held virtually, there was a dramatic decrease in participation and attendance and this has significantly affected our revenue. The net incoming resources for the year amounted to a surplus of £32,857 (2019 year end was a surplus of £77,572) all of which was attributable to general reserves.

I report on the Financial Statements of the charity for the year ended 31st December 2020 which are set out below.

1. Accounting Policies

1.1 Basis of preparation of accounts

The accounts are prepared under the historical cost convention and include the results of the charity's operations which are described in the Trustees' Report and all of which are continuing.

The accounts have been prepared in accordance with the Statement of Recommended Practice for Charity Accounts.

The Charity has taken advantage of the exemption in Financial Reporting Standard No. 1 from the requirement to produce a cashflow statement on the grounds that it qualifies as a small charity.

1.2 Tangible Fixed Assets for use by the Charity and Depreciation.

Tangible fixed assets for use by the Charity are stated at cost less depreciation.

Depreciation is provided at rates calculated to write off the cost or valuation of fixed assets, less their estimated residual value, over their expected useful lives on the following basis:

Plant & Machinery - Motor Vehicle	25% per annum.
- Equipment fixtures and fittings	25% per annum.

1.3 Income

Income from Tithes and Offerings is included in incoming resources when they are receivable.

Inland Revenue Gift Aid Repayment

IR Charity Repayment is gift aid repayment claims for the year on donations.

1.4 Value Added Tax

Value Added Tax is not recoverable by the Charity, and as such is included in the relevant costs in the Statement of Financial Activities.

2. Investment Income

Investment income consists of net interest received during the period.
