Committee's annual report For the 12 months ended 31st December 2024

The management committee, who are directors of the company and Trustees of the charity, submit their annual report and financial statements for the 12 months ended 31st December 2024.

Structure, governance and management

Homeless and Rootless at Christmas (HARC) was incorporated as a company limited by guarantee on 20th December 1994, and a charity registered with the Charity Commission on 29th September 1995.

All management committee members are members of the company and guarantee to contribute to the assets of the company in the event of it being wound up, to such amounts as may be required not exceeding £1.

HARC is run by a voluntary management committee who are elected each year at the Annual General Meeting. Management committee members have no beneficial interest in the company and are not remunerated.

Objects and activities

The objects of the charity are-

- The relief of poverty and sickness and in particular the provision of temporary accommodation and relief for homeless persons in Sheffield.
- The provision of grant aid to other charitable organisations within the area of benefit.

The charity meets the needs of men and women who are homeless, rootless, isolated or lonely over the Christmas and New Year period by providing a day centre offer meals, companionship, entertainment, access to services such as hairdressing. The charity also provides support for organisations who offer similar schemes throughout the year.

The management committee has taken due note of the Charity Commission guidance on public benefit.

Achievements and performance

The project in 2024 (Christmas Day and Boxing Day only) was a success in that the change in personnel (2 new project managers working as a job share) and venue (to the main hall in Victoria Hall) was managed well. We engaged a larger number of volunteers (158, of those 99 were new volunteers) and employed 3 Project Leads each day when previously we only had 2. This was in response to the need to make sure that guests and volunteers alike felt safe. We worked with other providers to help cover the days when HARC was not operating. Success was measured by the comments from our guests. They said that they preferred the new venue, felt safe and that the project provided a friendly caring environment. The quality of the food provided was very good and guests voiced their appreciation. Volunteers said that they enjoyed the experience and most said that they would volunteer again. Any issues were handled sensitively and efficiently by the Project Manager and the Project leads present. The number of guests on Christmas Day (no public transport) was lower than expected but this meant that volunteers were able to have hot food if they wanted it.



Funding from trusts and charities helped with our running costs along with generous donations from individuals and organisations across the city. Costs (venue and food) are again on the increase. We have increased the hourly rate of our Project Manager and Project Leads to reflect their responsibility and the fact that they were working solely on Bank Holidays during the project.

Many individuals and organisations gave clothes and toiletries as usual and those that were left over at the end of the project were distributed to other charities that support our clients during the rest of the year.

Numbers served, Christmas Day and Boxing Day Only-not compared to 2023

150 breakfasts
180 lunches
250 takeaway teas

We served all meals on metal crockery, with metal cutlery to make the occasion special. This meant that we created less waste than previous years when we used takeaway boxes and wooden cutlery. We continue to try to reduce waste. We did, however, still offer takeaway meals and hot drinks for those guests who did not want, for whatever reason, to come inside. The number that took up this offer was less than previous years.

A small Christmas gift was given to each guest with their Christmas meal. We provided warm clothes, hats, gloves, socks and toiletries as in previous years and thick warm coats and rough sleeping kits were also available. An emergency shower and clothes washing facilities were on offer for guests in need.

Entertainment provided by a drumming workshop, bingo, and Karaoke were popular as always. We will improve the sound equipment we have next year to cope with the bigger venue. One volunteer managed several guests playing chess (his particular interest) and this was very popular. The hairdresser was again very popular with guests appreciating this service.

Reserves Policy

The charity aims to maintain reserves at a level that covers running costs for 12 months. This equates to approximately £30,000.

The free reserves at the end of the year were £53,235, which equates to approximately 24 months of expenditure.

Exemptions

The Directors have taken advantage of the exemptions available to small companies including the audit exemption (see statement on balance sheet).

Directors' responsibilities for the financial statements

Company law requires the directors to prepare financial statements for each financial year, which give a true and fair view of the state of affairs of the company at the end of the year, and of the surplus or deficiency for the year then ended.

In preparing those financial statements, the Trustees are required to select suitable accounting policies and then apply them on a consistent basis, making judgements and estimates that are



prudent and reasonable. The Trustees must also prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

The Directors are responsible for keeping proper accounting records which disclose, with reasonable accuracy at any time, the financial position of the company, and enable them to ensure that the financial statements comply with the Companies Act 2006.

The Directors are also responsible for safeguarding the assets of the company, and hence for taking reasonable steps for the prevention and detection of fraud or other irregularities.

The charity meets the needs of men and women who are homeless, rootless, isolated or lonely over the Christmas and new year period by providing a day centre offering meals, companionship, entertainment, access to services such as hairdressing. The charity also provides support for organisations who offer similar schemes throughout the year.

The management committee has taken due note of the Charity Commission guidance on public benefit.

Achievements and performance

The project in 2023 was a success in that we served more meals and saw more people come into the Lower Hall at Victoria Hall than ever. This, not unexpected, increase in numbers of guests along with very wet weather conditions and a lower-than-normal number of volunteers lead to the project being faced with more challenges.

We are continually looking for new ways of bringing money into the project and this year we raised a good amount of money simply by placing a bucket on the bar of a pub near to Sheffield Wednesday football ground when there was a home match. Small pots of funding from trusts and charities helped with our running costs. Costs are still on the increase and we have increased the hourly rate of our paid workers to reflect their responsibility and the fact that they work on Bank Holidays. This year there was an overspend but with the money that we hold in reserve this is not seen as a problem. Many organisations gave money, clothes and toiletries as usual.

540 breakfasts (compared to 250 in 2022)

870 lunches (compared to 590 in 2022)

870 takeaway teas (compared to 590 in 2022)

We continued to offer takeaway meals and hot drinks for those guests who did not want, for whatever reason, to come inside and we will continue to review this.

The quality of the menu on offer continues to be of a high standard.

Many of our volunteers come back to HARC year after year as do our guests; we welcome the first but not so much the second.

We provided warm clothes, hats, gloves, socks and toiletries as previous years and thick warm coats and rough sleeping kits were also available. For the first time in this venue we were able to offer a shower and clothes washing facilities. This offer was not without problems which we will learn from.

Entertainment, bingo, Karaoke and visits from choirs were popular



The management committee, who are directors of the company and trustees of the charity, submit their annual report and the financial statements for the 12 months ended 31 December 2021.

Structure, governance and management

Homeless and Rootless at Christmas (HARC) was incorporated as a company limited by guarantee on 20 December 1994 and a charity registered with the Charity Commission on 29 September 1995.

All management committee members are members of the company and guarantee to contribute to the assets of the company in the event of it being wound up to such amounts as may be required not exceeding £1.

HARC is run by a voluntary management committee who are elected each year at the Annual General Meeting. Management committee members have no beneficial interest in the company and are not remunerated.

Objects and activities

The objects of the charity are:

- The relief of poverty and sickness and in particular the provision of temporary accommodation and relief for homeless persons in Sheffield.
- The provision of grant aid to other charitable organisations within the area of benefit.

The charity meets the needs of men and women who are homeless, rootless, isolated or lonely over the Christmas and new year period by providing, a day centre offering meals, companionship, entertainment, access to services such as hairdressing. The charity also provides support for organisations who offer similar schemes through the year.

The management committee have taken due note of the Charity Commission guidance on public benefit.

Achievements and performance

2021 was another challenging year and many of our usual fundraising events were unable to take place – however, online donations increased gain this year.

As a board we decided to operate 2021's project on the same basis as last year, within the Covid restrictions. Due to the fire and refurbishments at the Archer Project premises we relocated to Victoria Hall which is where the Sunday Centre operates from on a weekly basis.

We served our guests with hot takeaway breakfasts and lunches, and a takeaway sandwich.

Emergency use of toilets, showers and laundry and access to emergency accommodation were also available.

Numbers of guests using HARC this year was and improvement on last year, from Christmas Day to New Year's Day we served approximately 250 hot takeaway breakfasts, 590 hot takeaway lunches and 590 sandwiches/lunch bags.

We were unable to provide entertainment, activities, and guest services to clients due to COVID restrictions still being in place.

HARC 21/22 REPORT

HARC is still the main provision for homeless, rootless and vulnerable people in Sheffield over the Christmas period. The project in 2020 was an exceptional year because of the pandemic and we successfully delivered the project by offering a takeaway service at the Archer Project. However, due to the fire which affected the Domino Hall at the Archer Project we knew that we would no longer be able to use the Archer Project as the “home” of HARC and early in January 2021 the search began for a new venue. We work very closely with the trustees of the Sunday Service which serves meals every Sunday of the year to people who are also our guests at HARC. It therefore seemed the natural thing to do to enquire whether the Victoria Hall would be able to accommodate us. Rachael O’Leary the Events Manager and Tom Rattigan the Building Manager could not have been more helpful and Liz Grasso and I spent many hours on Zoom and in person sorting the fine detail to move the project to Victoria Hall. I would like to officially pass on our thanks to them and other staff at Victoria Hall for making the project possible this year.

Due to the continuing challenges of COVID we decided very early on that we would plan to again to have a takeaway food service. In the light of the new variant and the increased rate of infections this proved to be the correct decision and we were able to have a small number of guests to come inside to visit Elton, the hairdresser, Michaela, a community nurse and to the use toilet facilities. The kitchen facilities at Victoria Hall were not to the same catering standards that were used to at the Archer Project and because of this we decided to donate money to help buy an electric catering oven which will also benefit the Sunday Centre. Increased cold storage was also necessary and we bought a large catering fridge the cost of which will be offset by a reduction in our rent over the next 3 years.

We usually spend the months leading up to the project fundraising through events such as bag packs, Christmas markets, carol services, school assemblies. In 2021 we were able to access these sources of funding in a limited way; the Sharrowvale Xmas market and carol singing outside the Upper Chapel being a couple of things that were able to take place. We were able to trial our new devise for collecting donations electronically at the Xmas market and we also have lanyards that have a QR code that links directly to our Paypal account. We also now have a Wonderful Payment system that replaces our Just Giving page. Yes we

really have moved into the modern world but shaking a bucket and sending in cheques is still popular. Whilst not being able to have such a high profile around the city to engage with people the donations that we have received have remained high.

Again numbers of guests to HARC this year were lower. We think that this is probably due to some other projects opening on Christmas Day, because of COVID, and because of the move to a new venue. From Christmas Day through to New Year's Day, we served approximately:

- 250 hot takeaway breakfasts
- 590 hot takeaway lunches
- 590 sandwiches/lunch bags
- A total of 1430 meals

This number of meals is down on years when we are fully open but we hope that our numbers of guests will increase this coming year.

This year the provision of emergency accommodation for our guests was even more limited. Our experienced Project Leads were able to work with our guests to find the best option for them. The Project Leads also offered great support and guidance for our volunteers. Our Kitchen Lead did a sterling job keeping the kitchen working smoothly with the kitchen volunteers, producing amazing takeaway meals. We must again say a special thank you to our caterers, PJ Taste who devise excellent menu plans, manage our food order and deliveries etc.,

Thanks must go to our hard working Project Worker, Liz Grasso. Liz works for the project all year and keeps the whole show on the road, managing the trustees, the volunteers, our paid workers and sorting out the venue. Thank you Liz.

But as always, I would like to pass on the biggest thanks to our volunteers; the Trustees of HARC and the 200 plus fantastic volunteers who support us with fundraising and during the project from set up to close down.



1 Accounting Policies

(a) Basis of preparation
