Scouting takes place when young people, in partnership with adults, work together based on the values of Scouting and:

- learn by doing
- share in spiritual reflection
- take responsibility and make choices
- undertake new and challenging activities
- make and live by their Promise.

Objectives and Activities

The aim of the Group is that the Scout Association both and long term. The main objectives for the year have been to continue with the UK Scout Activity Programme. We will achieve this by providing as many resources as possible to encourage youth within our Group.

Achievements and Performance

The Group consisted of 34 members covering Beaver Scouts, Cub Scouts and Scouts with some Greenford District Young Leaders. In addition, there were 12 adults involved as leaders or administrators - all of whom gave their services voluntarily.

The headquarters also provided a meeting place for the Greenford & District Primus Explorer Scout Unit.

As soon as restrictions were eased we met face to face, held a Group camp at Southall Activity Centre, visited Brownsea Island for the day, group sleepover for Remembrance Sunday and took part in the District Remembrance Parade.

Financial Review

Grants from HM Government have helped to defray the loss of subscriptions and running costs. The Group has controlled its spending and continues to do so. The Group Executive continues to receive updates of the Group's cash and investments.

At the end of the year's income reserves amounted to £85,305. The Group's policy on reserves is to hold sufficient funds readily available to support the Group, Leaders, members and premises for which we are responsible. The Trustees believe the level of reserves is sufficient to support the Charity for at least twelve months from the date of approval of the financial statements.

Plans for Future Periods

The Group will continue to hold events to attract more adult volunteers as the demand for leaders continue. The Group will maintain its building as required. It is planned to renew two fire doors in the main hall, redecoration both internally and externally and continue with gardening works. A review of hire charges will be undertaken as overhead costs will increase in the coming year. The future direction of the Group is that of the Scout Association.

Structure, Governance and Management

During the year ended 31st March 2022 the Group Executive Committee has met on a regular basis via Zoom and face to face meetings to discuss administrations and support to the Group. We have referred to the guidance in the Charity Commission's general guidance on public benefit when reviewing our aims and objectives and in planning our future activities. In particular the Trustees consider how planned activities will contribute to the aims and objectives we have set.

The Scout Council complies with the detailed rules for the management of financial and operational risks mandated by the Policy, Organisation and Rules of The Scout Association. The Trustees actively monitor and review all risks which the Charity faces and confirm that insurances are in place to mitigate against sufficient risks that might arise.

The Group's governing documents are those of The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of The Association and the Policy, Organisation and Rules of The Scout Association.

The Group is a trust established under the rules which are common to all Scouts. Trustees are appointed in accordance with the Policy, Organisation and Rules of The Scout Association.

Trustees are drawn from all areas of Scouting and from outside the Movement. Elected members are proposed and seconded at the Annual General Meeting.

The Trustees, being the management personnel are all volunteers without remuneration.

Statement of Trustees Responsibilities


