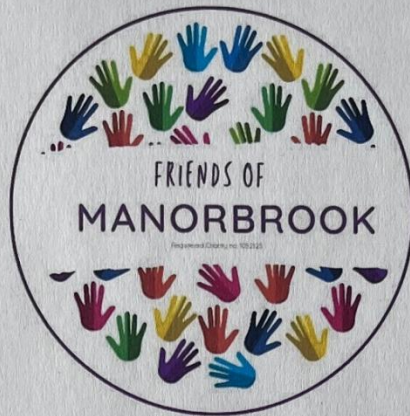

Overview

Friends of Manorbrook (FOM) is a registered charity run by parents who organise events for the school and the wider community.

These events include Summer and Christmas Fayres, discos, quiz evenings, cake sales, Scarecrow Trail and more.

FOM has raised tens of thousands of pounds for the school in recent years; which has been used to purchase items including playground equipment, interactive whiteboards, laptops, iPads, football kits, musical equipment, learning resources, class trip subsidies, coaches for the annual pantomime trips and more.

Meetings are held termly, with an Annual General Meeting (AGM) in September where new Trustees may be elected.

Review of the year 2024-25

Another successful year of fundraising was completed, with the year's programme packed with events for our community. Old favourites such as cake sales, discos, quiz nights, movie nights and break the rules day, and of course the summer and Christmas fairs, were accompanied by new additions such as gift sales for Mothers' and Fathers' Days, and the return of a bingo night and the sale of school tea towels.

Key financial support has been provided to the school via ongoing class trip subsidies, further items of playground equipment, classroom resources, new football kit, allotment tools and supplies, and support and catering for various events during the year.

A new fundraising target has been a new suite of iPads for the infant school, with the existing equipment very elderly and reaching end of life. We are very grateful to Sandra Davies at the Swan pub in Thornbury for her energetic and enthusiastic support running a program of fundraising events for this, as well as to the Thornbury Round Table and Renishaw plc for generous donations. As a result of this support and FOM events during the year, we have committed the funds to support this purchase.

Total income from events and donations in 2024-5: £19,537

Total gifts to the School/money out: £19,921

Plans for future years

The intention is to follow a similar calendar of events next year, with a managed transition to a new and expanded body of Trustees to support the growing needs of an expanding school. FOM is in a strong financial position to support the School with spending as required and as seen fit by the Headteacher and Staff, with £2,600 available at the beginning of school year 2025-6 in addition to the earmarked iPad funds and ongoing subsidies for class trips for the next year.
